# SRPMIC Hosts Annual D-Backs Inter-Tribal Youth Baseball and Softball Tournament

Native American youth from the Salt River Pima-Maricopa Indian Community, surrounding communities and across Indian Country participated in the 21st annual Arizona Diamondbacks Inter-Tribal Youth Baseball and Softball Tournament from May 29 to June 1. The

purpose of the annual tournament is to promote youth baseball and softball.

Like past years, the games were played at multiple locations in the Community, including the small fields at Salt River Fields at Talking Stick, the Way of Life Facility Little League field and the Salt River Recreation ballfields. Softball games were played at Papago Park in western Scottsdale and at Salt River High School.

More than 1,125 athletes from 75 teams representing more than 23 tribes from Arizona, New Mexico, California, Utah and South Dakota participated.

Pool play and the tournament were broken into four age divisions: Single A (9-12), Double A (13-15), and Triple A boys and Triple A girls (both high school age). The Gila River Bears took first place in the Single A division, the AZ Savages took first in Double A, the

# Aspiring MLB Player Signs to Play University of New Mexico Baseball Next Season

Salt River Pima-Maricopa Indian Community athlete Aaron Makil continues to follow his dream to one day join Major League Baseball (MLB). The 21-year-old recently graduated from Chandler-Gilbert Community College, where he signed to play baseball with the CGCC Coyotes right out of high school in 2016.

In early April, Makil announced that after graduating from CGCC he was signing on to play with the Lobos at the University of New Mexico for the 2020 season.

"It's exciting," said Makil about transferring to a university next year. "I didn't really talk to anyone about going to a university. The Lobos saw me pitch in the fall, and they contacted me expressing their interest and continued to follow up with me. I eventually went up [to Albuquerque] for a visit and I loved it up there."

The Coyotes' pitcher started his first year at CGCC playing

both pitcher and shortstop, but in his second and final season he remained the team's pitcher.

Academically, Makil hopes to study kinesiology to learn how the body functions and possibly have a career in sports medicine.



### Volkswagen Settlement Helps **SRPMIC Get New School Bus**

A 2016 settlement that involved automaker Volkswagen and billions of dollars has a tiny connection to the Salt River Pima-Maricopa Indian Community in the form of an 84-passenger school bus.

The German automaker agreed to pay up to \$14.73 billion in that settlement regarding allegations that it cheated on vehicle emission tests and deceived customers. More than half of the funding was to compensate consumers under the program, and nearly \$5 billion went to mitigate the car pollution and invest in clean vehicle technology.

Of that, \$2.7 billion was earmarked for a mitigation trust fund to help compensate for the environmental damage done or potentially done by vehicles sold in the settlement time frame, according to a 2016 Indian Country Today analysis.

About \$50 million of the mitiga-

tion trust fund was set aside for Indian tribes. This is how the Community got involved. The SRPMIC Community Development Department filed the required paperwork for the first funding cycle (2018-19) and was awarded \$192,886, which was used to reimburse the Community for a recent Blue Bird yellow school bus purchase.

In all, 26 tribes across the U.S. were awarded money. Besides SRPMIC, the Gila River Indian Community and White Mountain Apache Tribe were the only other Arizona tribal communities to receive funds.

The awards were based on reservation size and population.

The Community will continue to apply each year in the subsequent funding award cycles.


"It gives me something to look forward to and forces me to be like her and get where I need and want to go, because I know it's going to be tough these next couple of years trying to make it in the MLB," he said.

# SRPD Public Safety Dispatch Supervisor and SRPD Officer Receive Lifesaving Award

Salt River Police Department On Wednesday evening,

May 29, Salt River Police Department (SRPD) Public Safety Dispatch Supervisor Marcy Thomas and SRPD Police Officer Nicholas Daniels received the prestigious Lifesaving Award from SRPD Chief Karl G. Auerbach during the Salt River Pima-Maricopa **Indian Community Council** meeting.

On Monday, May 20, at 6:40 a.m., SRPD police officers were dispatched to Casino Arizona, where a non-Native customer was unresponsive and not breathing due to an overdose.

SRPD Public Safety Shift Supervisor Marcy Thomas took the initial 911 telephone call, obtained details and immediately entered call for service for both Salt River Fire Department EMS and police units. Units were dispatched within 30 seconds to the loca-

Thomas remained on the phone with the caller while police and fire units were en route, providing continuous pre-arrival medical instructions, including CPR. SRPD Police Officer Nicholas

Daniels arrived on scene within three minutes after being dispatched. He ran to the front entrance of Casino Arizona and found the victim lying on the ground; she was not breathing and had a faint pulse.

Off. Daniels immediately initiated continuous CPR and emergency medical care. Casino Arizona Security assisted with CPR while Officer Daniels administered two applications of Narcan to the victim.

Within two minutes, the victim was revived. Officer Daniels was able to successfully establish a good heartbeat and the victim began to breathe on her own.

Salt River Fire Department professionals arrived on scene about one minute later. They transported the victim to a local hospital, where she made a full recovery.

SRPD Public Safety Shift Supervisor Marcy Thomas used calm, clear, direct verbal communication and provided lifesaving instructions, allowing the caller to render immediate aid and CPR to the victim. When Off. Daniels arrived on scene, he immediately continued the CPR and then deployed Narcan. The teamwork of these two SRPD team

members working together saved the life of this adult victim.

After the Lifesaving Award presentation, SRPMIC President Martin Harvier commented very positively upon the actions of the SRPD team

members, who were joined at the presentation by SRPD Command staff and family.

Chief Auerbach said, "Our Community and the SRPD are so very fortunate to have such a dedicated and proficient public safety dispatcher supervisor

and police officer serving and protecting the Community. We are very proud of Marcy Thomas and Off. Nicholas Daniels and so glad they are on the SRPD Team!"


"I was doing really good [until I] noticed my face on the big screen; then realized I had stopped dancing," said Roberta Seepie, laughing.

### **Cherokee Actor Wes Studi Receives Oscar**

Veteran actor West Studi (Cherokee), known for a variety of acting roles in movies from "Dances With Wolves" to "Mystery Men," was selected to receive an Honorary Oscar for his career achievements.

Studi and three others are winners of the 11th Annual Governors Awards, an honor voted on by the Academy of Motion Picture Arts & Sciences Board of Governors. The announcement was made on June 3.

Studi is a fixture for Native American roles in numerous film and TV series. Last year he became the first Native American actor to host a segment of the Academy Awards ceremony.

"I am deeply honored and humbled," Studi said on his social media channels. "I finally get to say, 'I'd like to thank the Academy....""

## Navajo Man Announces Candidacy for U.S. President

Mark Charles, a citizen of the Navajo Nation, announced in May that he's running for President of the United States.

Charles made the announcement on May 28 via his YouTube channel. The nearly nine-minute announcement had close to 40,000 views as of early June.

Charles said he's running as an independent and wants to "build a nation where—for the first time—'We the People' truly means: #AllThePeople," according to his website.

### Canada Releases 1,200-page MMIW Inquiry

Canada's National Inquiry on Missing and Murdered Indigenous Women and Girls calls for "transformative change."

The 1.200 mass inquiry titled.

The 1,200-page inquiry, titled

"Reclaiming Power and Place: The Final Report of the National Inquiry into Missing and Murdered Indigenous Women and Girls," was released to the public on June 3.

More than 2,380 people participated in the inquiry, which tells a story "or, more accurately, thousands of stories of acts of genocide against First Nations, Inuit and Métis women, girls and 2SL-GBTQQIA (Two Spirit, lesbian, gay, bisexual, transgender, queer, questioning, intersex and asexual) people," reads the executive summary.

The report outlines more than 230 recommendations for the people of Canada to work together to end the epidemic.

### Maine Bans Native American Mascots at Public Schools

In May, Maine became the first U.S. state to ban the use of Native American mascots in public schools.

Maine Governor Janet Mills signed the bill into law after it was passed unanimously in the state legislature. The law prohibits public schools from adopting a name, symbol or image that depicts Native American imagery.

### Two More Navajo Code Talkers Walk On

Navajo Code Talkers William Tully Brown and John Pinto, a former New Mexico state senator, passed away in the last month.

Pinto died on May 31 and Brown's death was announced on June 3. On May 13, Fleming Begay passed away, leaving only a handful of Code Talkers alive.

"The Navajo Nation mourns the loss of our warriors, who utilized our sacred Navajo language to protect the country and Navajoland during World War II," said Navajo Nation Vice-President Myron Lizer in a statement.

# **Diabetes 101: Know Your Numbers**

The Diabetes Program of the Salt River Pima-Maricopa Indian Community is presenting Diabetes 101, a series of educational workshops for those living with diabetes to help them take charge of their health. Part 1 was discussed in an article in the April 18 issue of O'odham Action News and reviewed the three types of diabetes: type 1, type 2 and gestational. Part 2, "Finding Good Solutions," appeared in the May 2 issue of the newspaper and focused on understanding and managing blood glucose levels. Part 3, the importance of healthy eating and physical activity in managing diabetes, appeared in the May 16 issue. Part 4, "Know Your Medications," discussed the different types of medications that lower blood glucose levels orally or by injection to help manage diabetes.

In this article, Part 5, "Know Your Numbers" discusses why it is important to know your blood pressure, glucose levels, A1c and other important numbers when you visit the doctor to stay healthy.

It is important to monitor yourself when you have diabetes to prevent common complications that can arise, such as heart disease, eye problems, neuropathy (nerve damage) and kidney disease.

"We monitor so that we can make lifestyle adjustments that will help us manage our diabetes so we know where we should be," said Clinical Services Manager Marianne Bannett. "If we know where we should be, then we can use the numbers we get to make those adjustments to prevent any damage to our bodies."

### **Blood Pressure**

If you have diabetes, you should track your blood pressure; a person with diabetes should have a blood pressure of 130/90 or better. If high blood pressure is not treated, it can cause damage to blood vessels, leading to cardiovascular disease, vision problems and kidney failure.

### **Blood Glucose and A1c**

The average blood glucose target value for persons without diabetes should be 70 to 100 mg/dL before meals and less than 140 mg/dL after meals (within 40 minutes). People with diabetes should try to keep their blood glucose at 80 to 130 mg/dL before meals and less than 180 mg/dL one to two hours after meals, with an A1c less than 7.0. The A1c is an average measurement of blood glucose over three months.

"A lot of people think just because their A1c is at 7 they are okay, but actually it should be less than 7," said Bannett.

One of the things you will need to do is to take your blood sugar several times daily; that will give you information that you can use, explained Bannett. For example, if you test your glucose after breakfast or any meal three days in a row, it can indicate what foods increase your glucose levels more than others.

### Glomerular Filtration Rate (Kidney Function)

Bannett also stressed the importance of requesting a printed copy of your lab results from your doctor. This way you can track your glomerular filtration rate (GFR). The GFR shows how well your kidneys are functioning. The lower the result, the lower your kidney function. As your kidneys lose function over time, you will start progressing through the five stages of chronic kidney disease.

"When your GFR drops to about 45 or so, your doctor may mention it," said Bannett. "It is important to request your labs and check for yourself, to review the results of the GFR. If it is at 60 or lower, start asking your doctor questions about how you should change your diet to prevent yourself from going lower." Certain medications also may help preserve your kidney function for longer.

The lowest stage of chronic kidney disease is stage 5, which is complete kidney failure. In this stage the GFR is 15 or lower, and patients must start dialysis. Dialysis is a process that cleans the blood of waste products because the kidneys can no longer do the job.

People in the early stages of kidney disease often have no symptoms. If you're not managing your diabetes properly, going from 60 percent kidney function down to 15 percent can happen quickly, so it's important to manage your glucose and blood pressure. It is also important to keep on top of your regular doctor visits and ask questions.

"We want patients to be aware," said Bannett. "The most important person on your medical care team is you."

"To me, it's a big accomplishment," Kaye said. "I never thought I would go this far with it. I would encourage everybody to continue [pursuing their education]. I'm hoping to make a big change within the

Community because I know how it is to be addicted, using alcohol."

Kaye isn't done with her education. She's studying for her next certificate, in Addictions and Substance Use Disorders Level II, and after that she will work on earning an associate degree.

She's one of more than a dozen SRDOC inmates enrolled in college courses.

Denelle Prieto, Higher Education Program advisor, encouraged Kaye to continue her education journey because it will benefit her and many others. "You're going to help our Community," Prieto said to Kaye.

SRDOC officer Danny Brown, program coordinator, works closely with the students. He said he was proud of all the students, adding that he was "really proud of Sarabeth—what an achievement."

and this really prepared me."







# SRPMIC Public Works Department Celebrates National Public Works Week

National Public Works Week was May 19-25, and the Salt River Pima-Maricopa Indian Community Public Works Department celebrated along with all the other public works departments across the United States. The American Public Works Association (APWA) sponsors the weeklong event every year to recognize the many facets of modern civilization that grow out of the efforts put forth by the public works professionals across North America, according to the APWA website.

The theme for 2019 National Public Works Week was "It Starts Here." The week started off with a vendor kickoff event on Monday highlighting the vendors that Public Works uses, the companies that supply everything from cleaning supplies to first-aid kits.

Wrapping up Public Works Week was a 2.6-mile walk from the Public Works Administration office to the Salt River Community Building. The walk started off with a welcome by Assistant Public Works Director Dawn Sinoqui, who expressed her appreciation for all the hard work the entire department does for the Community. 



# **VOAD Training: Electricity Safety**

With monsoon season approaching, we can expect to see or hear about downed power lines in various locations around the Valley. Not only do downed power lines cause power outages, they also are dangerous and may cause injury and even death.

The featured topic at the June 4 Voluntary Organizations Active in Disaster (VOAD)/Community Emergency Response Team (CERT) training session at the Two Waters Complex was Electrical Safety Awareness. Salt River Pima-Maricopa Indian Community employees and Community members learned safety techniques for dealing with electricity and power

If you should come across a downed power line, always keep a safe distance—10 feet is the recommended minimum safe distance. Why stay away? Because the line could still be energized and could transmit an electric shock to anything around it, including the ground. Call 911 and they will dispatch Arizona Public Service or Salt River Project to safely take care of the situation.

Use caution when working outside in areas with overhead power lines. Accidentally hitting the overhead lines with equipment, ladders and tools can cause severe injury or death. Although power lines appear insulated, they will not protect you from a shock if you come into contact with them.

Remember to stay away from anything touching a power line; it is as dangerous as touching the power line itself.

If your vehicle comes into contact with a downed power line, stay inside the vehicle until help arrives. If you must leave the vehicle due to other hazards, don't touch any metal. Jump out and land with both feet close together, then shuffle as far as you can to get away from the power line. Never walk away normally, because this can cause your legs to be the bridge current from higher to lower voltage, resulting in a

### **Safety Tips for Electricity in the Home**

### **Outlets and Switches**

- · Make sure all switches and outlets work properly
- Are any switches or outlets warm to the touch?
- Do any switches or outlets appear to be burned? · Do any switches or outlets
- make cracking, buzzing or sizzling sounds?
- Does each switch and outlet have a cover or faceplate?
- Are any of the covers or faceplates broken?
- Are any outlets and switches loose or coming off the
- · Are any outlets overloaded with too many plugs?

If you see a person come into contact with an energized line, do not attempt to save them, because it can only result in you also becoming a victim. Call 911 and wait for help to arrive.

### **Electrical Cords and Power Strips**

- · Are you using an overloaded power strip for appliances or equipment? Be sure to use the appropriate power strip.
- · Make sure cords are not cracked or damaged. If you can see exposed wire, then it's time to replace the cord.
- · Make sure cords are not wrapped up while being used.
- Never connect two or more power strips together.
- · Pay attention to appliances; if they are overheating, it may be time to replace them.
- If you see sparks from any appliance, replace it.
- If your circuit breaker trips when you use an appliance, make sure to install the appropriate size breaker.
- · If you notice a recurring tripped circuit breaker or blown fuses, consult an electrician.

Finally, test your smoke detectors every six months and replace batteries when necessary.

# Vandals Desecrating Cemeteries at Night, Community Input Sought

The Salt River Pima-Maricopa Indian Community Public Works Department, along with Memorial Services and Cemeteries staff, are seeking input and comments from Community members regarding a proposal to close the Salt River and Lehi cemeteries at night

Over the past few years, the Salt River Police Department has been receiving an increased number of calls regarding incidents at cemeteries, including abandoned vehicles, tagging, trespassing and desecration of gravesites. Other incidents being reported to the Public Works Department include Community members making recordings and posting photos on social media, trespassers who have fallen asleep in the cemeteries, and individuals who enter the cemeteries late at night to see "ghosts." Public Works staff also have found increased amounts of drug and alcohol paraphernalia in both cemeteries. These incidents are occurring at all hours, including daytime hours.

These incidents are very disrespectful and have offended and hurt numerous Community members with family members at rest in the cemeteries. It used to be that the Community as a whole knew to be respectful in cemeteries. Community elders say that they were taught not to enter cemeteries at night. It was also mentioned that perhaps due to the recent increase in deaths within our younger generation, younger people are visiting the cemeteries who may not have been taught to show proper respect and behavior.

Currently, the gates at both cemeteries are kept open at all times. While the cemetery staff maintains and monitors the cemeteries during normal business hours, no one is assigned to monitor the cemeteries after the cemetery crew has left for the day. The Salt River Police Department is aware of the problem and is doing its best to monitor the cemeteries.

To reduce the number of calls to the police department during the late-night hours and in turn reduce criminal activity at the cemeteries, there is a proposal to establish cemetery hours of operation and lock the gates from dusk

to dawn. Families would feel better knowing the graves of their loved ones are secure.

If you are at one of the cemeteries paying your respects to a friend or loved one and notice anything out of the ordinary or see any suspicious activities, please call 911 or Salt River Police Dispatch at (480) 850-9230 for non-emergencies.

### **Notice Regarding Amendments to the** Illegal Dumping Ordinance

On June 5, 2019, the Salt River Pima-Maricopa Indian Community Council approved amendments to several sections of Chapter 13 of the Code of Ordinances. The goal of the amendments is to clarify the civil and criminal penalties for illegal dumping. The fine for criminal illegal dumping will increase from a range of \$50 to \$500 to a range of \$100 to \$1,000. The maximum term of incarceration will remain the same, six months. The amendment also clarifies that any fines imposed are in addition to the costs the Community incurs in addressing the illegal dumping. The amendment also decreases from 30 cubic yards to 1 cubic yard the quantity of material that would subject a vehicle and/or trailer used in illegal dumping to forfeiture.

The amendments will be posted to the Community's intranet site. You can also contact the Office of General Counsel and we can provide a copy of the approved amendments.




