The primary narrowed the field of candidates for the general election, which will be held on September 6 to determine the Community's top two leaders and new Council members

Over three days, July-17, the Lori Piestewa National Native American Games brought tribal youth from across the country to the Valley for some great sports competition, including championship basketball and baseball tournaments. Players of all ages showed off their prowess in various sports at venues across the Valley.

Basketball

In total, there were 73 boys' teams, 57 girls' teams, 17 men's teams and 15 women's teams


competing in their respective divisions. Five teams represented the Salt River Pima-Maricopa Indian Community.

Starting off the lineup of SRPMIC teams was the Salt River Renegades in the 4th Grade co-ed division, who would drop their first game against the Court Queens, 42-12. For these little ballers, their outing at the tournament would be about having fun and getting introduced to tournament basketball. They finished in seventh place in their division.

Stepping up in age, the up-and-coming Ba'ag JV team started their tournament hot, besting their opponent Not Elite 64-27. They rode their hot streak into the

semifinals until being upset by Bemo Elite in a close matchup, 63-58. They would make a run for the JV division championship. Overall, the Ba'ag JV team finished the tournament in a respectable fourth place out of the field

Moving on to the Varsity division, teams like The River, Ba'ag and TE were on a mission to stake their claim at the championship. The River team brought their best stuff early in the tournament, handling their opponent Apache Boys in the first game with a score of 50-46. Although The River had a brief appearance in the Piestewa Games, they made an impact. The team ended up placing 15th out of 24 teams, but there was plenty of ball ahead, as they would form the Ba'ag 2023 in the Native American Basketball Invitational.

Another SRPMIC varsity team, TE, helmed by SRPMIC Council member Wi-bwa Gray, fielded their way into the tournament. The team started off slow, losing to NAZ Soldiers in their first game, but they found success in later games, breaking even in tournament play and finishing 19th overall.

In the Varsity division, the high school Ba'ag team put their best foot forward from the start, beating Apache Boys 50-46. The team, full of talented athletes, was on a good run throughout the tournament but failed to punch their ticket into the finals after losing to Bemo Elite 63-58 in the semifinals.

In the 7th and 8th Grade girls' division, the Zona Soldiers took the championship title after beating six teams in their bracket. Natives With Talent's (NWT) JV team made it to the final four in their division, playing against the Shnacks'n'Buckets team. Shnacks'n'Buckets defeated NWT 57-40 and went on to win the championship in the Girls' JV Division. NWT's varsity team made it to the final four in their division, then was defeated by Dem Lady Sleepers, who went on to win the championship. Unfortunately, AZ Lady Warriors did not make it to the championship bracket, getting to play only three of their pool games.

Baseball

Two teams represented the Community in the Lori Piestewa Games' youth baseball tournament: the Bulldogs and SR Chargers. Youth ages 9-12 played at the Salt River Baseball Field and Way of Life Facility fields in triple-digit temperatures. All teams played three games; each game had seven innings and a one-hour time limit. A number of adult SRPMIC members participated on softball teams in a tournament held at Bell Bank Park in Mesa.

Although many of the teams fell short of the championships, their determination was nothing less than the prize. For some teams, it was a dress rehearsal for the NABI tournament and a chance to play as a cohesive unit to find success.

The Lori Piestewa National Native American Games is organized by Grand Canyon State Games and also includes competitions in softball, cross country, track and field, volleyball and wrestling. Lori Piestewa was killed in the Iraq War in 2003. Born in Tuba City of Hopi and Mexican heritage, she was the first Native American to die in combat while serving in the U.S. military and the first woman in the military killed in the Iraq War.

In July, the Community Recreational Services Department of the Salt River Pima-Maricopa Indian Community held two summer camps, one for tweens and one for teens, both of which included a Career Day. On that day, a Career Fair was set up to introduce the youth in grades 6 through 12 to SRPMIC government departments, higher education opportunities and successful individuals who have created their own businesses. The goal was to offer insight into different jobs, training and education to help them choose their career paths.

"We wanted to put on this Career Fair because these youth are at that age where they should start thinking about what they want to do after high school, start thinking about different career fields, education and what they want to do with their lives," said Recreation Coordinator II (Social) Kevin Riding In.

During the Career Fair for the junior high school students, Community Recreational Services Director Rebecca Makil talked to the youth about her own career journey from a youth worker to serving as director of Community Recreational Services. She encouraged youth to sign up with the Workforce Innovation and Opportunity Act (WIAO) Program at the Community's Human Resources Department and work with Community Recreational Services as concession workers, lifeguards or scorekeepers in the Social or Athletics division.

Assistant Human Resources Director Crystal Banuelos gave a presentation on what the Community Human Resources Department provides, including jobs and training to help youth start their careers. The Career Fair featured booths from local colleges and SRPMIC government departments.

Severe Storm Ravages the Community, Causes Widespread **Damage**

A severe monsoon storm struck the Salt River Pima-Maricopa Indian Community in the late evening between 8 and 9 p.m. on Sunday, July 17. Several homes, power lines and pieces of infrastructure were damaged or completely destroyed by high winds, prompting the Community to make a formal disaster declaration.

In the wake of the storm, the Salt River Fire Department, Public Works Department Salt River Police Department, Salt River Health & Human Services (HHS) sprang into action to assess the damage. For Community members left without power and unable to find comfort at home due to the warm temperatures, cooling stations were set up at SRFD Fire Station 294 and the Lehi Community Building. Individuals whom were significantly impacted by the storms were provided short-term housing solutions through Salt River

According to information provided by Emergency Manager Charles Kmet of the SRPMIC Office of Emergency Management and data collected by the National Weather Service, the severe thunderstorm which has been classified as a macroburst produced winds of 80 to 100 miles per hour.

As a result of the intense winds, close to 200 Community homes received varying degrees of damage, including


loss of shingles and awnings and water damage. Some trailer homes were completely destroyed. In addition, the high winds downed a total of 16 power poles and five transmission towers.

For those Community members displaced by the storm, HHS conducted intakes to assist with temporary housing. Meanwhile, the Engineering and Construction Services Department carried out damage assessments. Community Development (CDD) also assisted HHS and ECS with support to take information and establish resources.

The extent of the damage encompassed an area of about 4 square miles north of State Route 202, down to north Alma School Road and east of Gilbert Road, according to an OEM informa-

Due to the severity of the storm and its lasting effects, some Community members are still unable to return home and are living in temporary housing. To assist with timely and effective recovery efforts, the Community has requested that the Federal Emergency Management Agency (FEMA) come out and participate in Preliminary Damage

Assessments (PDAs) from August 1-3.







2022 NABICHAMPIONS AZWARRIORS

NABI Tournament Draws Teams from Across Indian Country in Phoenix

The annual Native American Basketball Invitational (NABI) attracted teams from across Indian Country to Phoenix for a week of hardwood action, July 18-23. This year marks the 19th year of the tournament, which took place at various gymnasiums around the Valley.

This year's tournament fielded 68 boys' teams and 68 girls' teams, all of which competed for the championship in their respective divisions. The Salt River Pima-Maricopa Indian Community had a handful of teams whose rosters consisted of Community members.

On the first day of the tournament, the boys' Ba'ag team started things off with a victory, besting opponent NW Hoopers by small margin of 68-65 to start NABI play on a good note. The game was back and forth until the NW Hoopers made a late push to get the lead and stay in front. Ultimately, Ba'ag would find their stride and regain the lead on a couple of free throws, while draining the clock down to get the win. However, for the Ba'ag team, their chances at a title run were stumped as their advance to the championships was ended by AZ Northern Footprint, 45-43, in the bracket phase of the tournament.

On the girls' side, the AZ Lady Warriors looked to get their momentum going early against the TC Elite from Valley Lutheran High School in central Phoenix. The game was a tight race between both sides, as

no one wanted to let the other have the lead for long. Unfortunately, the Lady Warriors lost their step late in the game, while fouls called by the referees sent TC Elite to the free-throw line to scoop up some extra points. With time not on their side, the Lady Warriors settled for a loss heading into bracket play. Although the AZ Lady Warriors were able to bounce back during a later game against M&M Academy, they exited the tournament at the hands of Zona Soldiers, falling 41-39.

Next up was AZ Warriors Red, who put on an impressive display out on the court at the Camelback High School gymnasium against their opponent WE R1. In that contest, the AZ Warriors held their own against WE R1 in another close game that got down to the wire. With a few late-game resurgences, the AZ Warriors held WE R1 at arm's length until the there was no more time on the clock for WE R1 to make any late comebacks. With that effort, it would send them into bracket play, where they won 55-44. In another close matchup to advance in the bracket, AZ Warriors would face stiff competition from White Hillz in a hotly contested game that came down to a 2-point difference. In the end, the AZ Warriors were eliminated from the tournament 45-43, while White Hillz moved on

Elsewhere in the NABI Tournament

Fort McDowell had some SRP-MIC representation; the team was undefeated in pool play and won

their first bracket game by forfeit. They also won their second bracket game, but they were ultimately defeated by Northern Elite and pushed down to the loser's bracket. In their third game in the loser's bracket, they were defeated by the Oklahoma Runners, losing by only 1 point, 63-62.

Ba'ag 2023 played five games, losing in their first bracket game and moving to the loser's bracket. Unfortunately, they lost to White Hillz in another close battle, 59-62.

SR Tribal Elite were 0-3 in pool play; they lost their first bracket game against the Gunnerz, moving them to the loser's bracket. There, they won their first game, against the Gladiators, 58-48. But the SR Tribal Elite were pushed off the bracket by Omaha Warriors, 70-46, ending their NABI journey.

In the girls' division, Natives With Talent (NWT) made it to the final four. The girls went head-to-head with Oklahoma team Legacy Elite; Legacy Elite defeated NWT, 45-51.

"It felt better; we had more chemistry with everything—passing, cutting, shooting. It was a good overall year," said Angelina Montoya of NWT. "I look forward to playing with this same team and having the chemistry."

For one of the team's seniors, Nyese Jones, this was her last year playing in NABI, as she is moving on to the college level. She hopes to help her father, NWT head coach JJ Jones, with coaching duties in the NABI tournament next year.

"We made it farther than we did the last couple of times we played," said Nyese Jones. "It's a little bit sad that we lost, but we were in the top four teams out of 68 teams in the girls' division, and we were able to get our name out there."

The AZ Warriors went undefeated in this year's NABI tournament, winning 10 straight games. They beat Northern Elite on the Phoenix Suns and Phoenix Mercury home court at the Footprint Center on Saturday, July 23. The team's players represent Native American tribes including the O'odham, Hopi, Navajo, Apache and Klallam. This is the third NABI championship title for the intertribal basketball team, which won back-to-back in 2015 and 2016.

Robert Johnston, coach of the champion AZ Warriors, said, "This is one of the things I just had to show up to. My staff and coaches have done an excellent job working with these kids and making things happen. [G]etting these kids prepared and letting them play the sport—that's what it's really all about. I am just happy to be here with everyone, and I look forward to working with the next generation of children. For the ones who are ready to play, our coaches are ready for them and to help them develop."

Although some of the teams did not make it to the finals, their hard work in playing every game demonstrated how much basketball is life for youth from Salt River. Congratulations to all the SRPMIC teams for coming out and representing the Community throughout a week of tournament basketball.







Meet Charles Kmet, the New SRPMIC Emergency Manager

In June, the Salt River Pima-Maricopa Indian Community said farewell to longtime Emergency Manager Cliff Puckett. One month later, during monsoon season, which is one of the busiest times for the Emergency Management team, Charles "Chuck" Kmet was named the Community's new emer-

gency manager.

"Cliff built this program to where it was easy for me to come in at a time when the Community was recovering from storm damage and jump in and help," said Kmet. "I actually sent Cliff a text a couple of days ago and told him thank you for making this so easy for me. The program that he has built and the team that he has, which I have adopted now, are top notch, and the relationships that he has built with all of the [SRPMIC] departments and the executive administration [are outstanding]. [I would describe my transition with] the term 'hit the ground running.' I feel that I have not stumbled during this time."

Kmet started his career in 1992, working as a firefighter/paramedic in

Virginia and in Atlanta before moving to Arizona in 2002. In 2003 he started working with the Tohono O'odham Nation as fire captain, and after a year he became the assistant fire chief.

After federal mandates came down with

regard to how public entities respond to emergencies, the Tohono O'odham Nation adopted a resolution to create its own emergency management program. Kmet was asked to take the lead on creating the Office of Emergency Management there.

"I was creating the program in the Tohono O'odham Nation when Cliff was here in Salt River creating the Community's Emergency Management program. It was neat to bounce ideas off each other and see how things were going while we were creating these programs," said Kmet.

Public Works Department Survey Sheds Light on New Project

A new addition is coming to the Salt River Pima-Maricopa Indian Community to improve the safety of its roadways. The SRPMIC Department of Public Works is initiating a new streetlight project, and the department is asking for input from Community members about desired nighttime street and sidewalk lighting in selected areas of the Community.

An online survey will help determine people's opinions regarding streetlights and how far the Community should go in providing lighting along stretches of planned sidewalk development in the Community.

"We created a webpage that asks a couple of questions to try to get a better idea of what Community members want to have in terms of streetlighting," said Rick McFarlin, Public Works project manager. He said the main idea for the project is to create a safe environment for pedestrians and drivers within the Community. One project involves the construction of sidewalks along Mesa Drive from Indian School Road to the Arizona Canal, and along Camelback Road from Center Street to Mesa Drive. "As part of the [sidewalk] project, we received funding for streetlights, which

will be installed on Indian School and Camelback," said McFarlin.

McFarlin said Community members have expressed concerns that there is not enough lighting because the current streetlights are too far apart to provide adequate coverage.

He said there are different lighting settings that Community members can choose from or comment on. Choices include the dark-sky and rural setting, which means no extra lighting and everything stays as is; select settings, meaning lighting installed at bus stops and intersections, places which are at high risk for accidents; and the urban setting, with lighting along major streets and high-traffic residential areas.

McFarlin said that recent responses have varied from maintaining a more natural setting with minimal lights to some people who would like to see the sidewalks lit similar to those in the neighboring city of Scottsdale. Others stated that they would like to see lighting only at select locations.

Another project in the works involves Mesquite Trails and the Canal Side neighborhood, where it was determined that lighting coverage needed to be increased. In that project, Public Works will add lights to fill in the gaps between the current streetlights.

Youth Beat the Heat by Participating in Fitness Challenge





During the month of June and July, SRPMIC youth took part in the Move with Miles Challenge, that was hosted by Youth Services Program and the Health & Human Service: Diabetes Services Program. The youth ran and walked over 600 miles to surpass their 500 mile goal.

Salt River Pima-Maricopa Indian Community youth got moving during a special two-month challenge hosted by the Youth Services Program and the Health and Human Services Diabetes Services Program. During June and July, for the Move with Miles Challenge, SRPMIC youth racked up 635.3 miles at the Way of Life Facility's indoor track.

"We collaborated [with Health and Human Services] to create an opportunity for youth to get involved in physical activity," said Youth Development Supervisor Debra Apodaca with the Youth Services Program

"About physical fitness, our recommendation is to get our youth to move at least 30 to 60 minutes a day, with the goal of reaching 500 miles at the end of the challenge," said Otellie Honanie, Physical Fitness Specialist for HHS DSP. She said the goal was to work out 150 minutes a week. Walking and running were the primary activities for the Move with Miles Challenge.

The youth were separated into groups with names such as the E, Junior Quail, Quail, Roadrunner, Hawk, Hummingbird and Victory Acres II (VA II). They would see who logged the most miles at the completion of the fitness challenge.

"We focused on two weeks, due to other programming, which was done over eight days, where they would run or walk on the indoor track for 30 minutes or even 60 minutes for some groups," said Apodaca. She said the groups were competitive and pushed to log as many miles as they could each time.

With each group logging their own miles, the youth enjoyed the activity, because it created an opportunity for them to exercise together and improve their own well-being. "It encouraged them to create a routine of doing exercise every day. We even had some groups wanting to walk and run twice a day," said Honanie.

She said the other purpose of the challenge was to instill the idea that, no matter what level of physical fitness they are at, children are capable of being active. Apodaca said many of the youth told her they would like to see more fitness challenge activities, because they motivated each other to keep moving.

On top of the peer motivation to get moving, the groups and individual runners received recognition and prizes for logging the most miles. After the first half of the fitness challenge concluded, the two groups with the most miles logged were the Hummingbirds, with 100.4 miles, and the Hawks, with 96.5 miles.

The Hummingbirds members received tickets to Harkins Theatres, while the Hawks received a Jamba Juice party. In terms of individual competition, the first-place finisher was awarded a bicycle for completing 19.3 miles. The participants in second place received an electric scooter and the third-place participant came away with an electric scooter.

This will not be the end of the Move with Miles

Challenge—the same group of youth will continue to add to their miles in what is called the "Go the Extra Mile" Challenge, in which the youth can continue to walk or run to reach their goals.

Apodaca said the fitness challenge has been a positive experience for the youth. "One of our staff members oversaw an all-female group. They are the ones who really wanted to improve their self-esteem and have more time on the track—or even on the treadmill—to keep going."

As for other ideas to incorporate fitness into kids' lives, Honanie said, "We do plan to incorporate a strength program for the kids that is based around seasonal sports. We would like to see the youth staying active while setting [fitness] goals."

RESIDENCY ORDINANCE – Draft

Proposed Ordinance is Open for Public Comment Until August 10, 2022

The Salt River Pima-Maricopa Indian Community Council is currently considering the enactment of a Residency Ordinance. The purpose of the Residency Ordinance is to determine which non-members may be permitted to reside within the Community, track/monitor these non-members residing within the Community, and place requirements upon these non-members with respect to certain tribal programs like jury service (in limited cases). The following is a structural breakdown of the proposed ordinance:

Section 17-16 states the purpose(s) of the ordinance and defines certain terms. Section 17-17 specifies the various non-members who may reside within the Com-

Section 17-18 lists the requirements for registration by non-member residents. Section 17-19 includes civil violations for not complying with the proposed ordi-

Section 17-20 includes the obligations of non-member residents.

Section 17-21 re-affirms the Community's ability to utilize and enforce the exclusion

The proposed ordinance is open for public comment until August 10, 2022, and will be discussed at Council District Meetings throughout May, June and July. The Community Council is hoping to receive Community member feedback on this proposed ordinance. ORDINANCE NUMBER SR-XX-2022

AMENDMENT TO CHAPTER 17, ARTICLE I, SEC-TION 17-16 THROUGH 17-21 OF THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY CODE OF ORDINANCES TO EXERCISE THE COMMUNITY'S INHERENT AUTHORITY TO DETERMINE WHO MAY RESIDE WITHIN THE COMMUNITY AND TO DEVELOP A TRACKING SYSTEM TO COMPILE DEMOGRAPHIC INFORMATION ON RESIDENTS OF THE COMMUNITY TO AID IN PUBLIC HEALTH AND COMMUNITY SAFETY, AND TO ENHANCE THE JURY SERVICE PROCESS.

Chapter 17, Article I, Section 17-16 through 17-21 of the Salt River Pima-Maricopa Indian Community Code of Ordinances is hereby amended to read as

Sec. 17-16. Purpose and Definitions.

Purpose. The purpose of this Chapter is to exercise the Salt River Pima-Maricopa Indian Community's inherent authority to determine who may reside within the Community and to re-affirm the authority to exclude non-members from the Community when appropriate.

The purpose of the Community's compiling of nonmember individuals residing within the Community boundaries is to allow the Community government to plan for the public health and safety needs, facilitate an enhanced system for jury service in the Community Court, and provide awareness to all residents within the Community.

Definitions. For purposes of this chapter, the following definitions apply:

Commercial residential lease means a business lease

August 4, 2022

that provides residential services to non-Community members that has been approved by the Community pursuant to Chapter 17 of the Community Code of Ordinances or by the Bureau of Indian Affairs pursuant to 15 C.F.R. 162 and recorded in the Land Titles and Records system.

Community means the Salt River Pima-Maricopa Indian Community, a federally-recognized Indian tribe.

Council means the governing body of the Salt River Pima-Maricopa Indian Community.

Detention facilities are the adult detention facility and juvenile detention facility operated by the Salt River Department of Corrections.

Health care facilities are establishments providing residential care or treatment including, but not limited to hospitals, clinics, nursing homes, hospice care facilities, assisted living facilities, mental health treatment facilities, or substance abuse treatment

Intimate partner is a person who is in a social relationship of a romantic or intimate nature with a Community Member, as determined by the length of the relationship, the type of relationship and the frequency of interaction between the persons involved in the relationship.

Community member means any enrolled member of the Salt River Pima-Maricopa Indian Community.

Minor children are any persons under the age of eighteen (18) years.

Non-member means any individual who is not an enrolled member of the Community, including non-Indians and non-member Indians.

Reside or Residency means the place where a person actually lives. For purposes of this ordinance, remaining within the boundaries of the Community for longer than six (6) months triggers the requirements found in this section.

Sec. 17-17. Non-Members Allowed to Reside within the Community.

The following non-members are permitted to reside within the Community provided they have not been previously excluded pursuant to Chapter 7, Article III of the Community Code of Ordinances:

Current spouses of a Community member.

Widows and widowers who were married to a Community member, but whose spouse pre-deceased

Intimate partner of a Community member.

Parents of Community member minor children who have custody or partial custody of the Community member children.

Parent of an adult Community member.

Adult children of a Community member.

Minor children of a Community member.

Individuals who have a valid interest in real property in accordance with applicable Community and Federal laws, regulations and policy, but only on that property

Persons eligible for enrollment in the Community.

Patients or clients of a health care facility located within the Community, who are admitted to the facility for a minimum of 24 hours.

Individuals in a Community detention facility.

Individuals residing within the Community pursuant to a valid commercial residential lease that has been approved by the Community.

Other persons authorized to reside within the Community pursuant to a Council resolution.

Sec. 17-18. Registration Requirement for Non-Member Residents.

All individuals permitted to reside within the Community pursuant to Sec. 17-17 and who are eighteen (18) years of age or older shall be required to register as a non-member resident with the Membership & Real Property Management Division of the Community Development Department. Registration must occur by October 1, 2022 or within six (6) months of moving to a location within the Community. Registration shall include the following information:

Name;

Date of birth:

Tribal affiliation, if applicable;

Physical address within the Community;

Mailing address;

Telephone number;

Email, if applicable; and

The provision(s) from Sec. 17-17 under which the non-member is eligible for residency within the Com-

All individuals permitted to reside within the Community pursuant to Sec. 17-17 and who are eighteen (18) years or older shall also be required to update their registration information within three (3) months

of any changes to the information listed in Sec. 17-18(a)(1)-(8).

The following individuals permitted to reside within the Community pursuant to Sec. 17-17 shall be exempt from the registration requirement:

Minor children of Community members;

Patients or clients in Community health care facilities;

Non-member individuals in Community detention facilities:

Individuals residing within the Community pursuant to a valid residential commercial lease that has been approved by the Community. If the individual meets other criteria in Section II they shall be required to

be used by the Community for official government and law enforcement purposes, including a determination of whether the person meets the standards outlined in Section II.

Any information provided pursuant to this section may

The Membership & Real Property Management Division of the Community Development Department shall be required to maintain an updated list of nonmembers allowed to reside within the Community. The Membership & Real Property Management Division may remove an individual from the list if they are unable to locate them for at least six (6) months.

Sec. 17-19. Civil Violation of Residency Ordinance.

Any individual who is not permitted to reside within the Community and does so in violation of these residency provisions shall be subject to a fine in the amount of \$1,000.00 for a first violation and subject to a fine in the amount of \$2,000.00 for a second or subsequent violation.

Any individual who is subject to and violates the residency registration requirement or fails to update their residency registration information shall be subject to fine in the amount of \$250.00 for a first violation and subject to a fine in the amount of \$500.00 fine for any second or subsequent violation.

Any individual who aids or abets in the violation of the residency provisions of this section, including the the registration requirement shall be subject to fine in the amount of \$500.00 for a first violation and subject to a fine in the amount of \$1,000.00 for a second or subsequent violation.

Sec. 17-20. Obligations of Non-Member Residents. Non-member residents may be required to participate in the following Community programs, but not limited

Public health initiatives/programs.

Jury duty service in the Community Court.

Sec. 17-21. Exclusion of Non-Member Resident.

All non-Community members are subject to exclusion from the Community pursuant to Chapter 7, Article III of the Community Code of Ordinances regardless of their eligibility under these residency provisions.
