## River People Health Center Holds Official Grand Opening

After a successful soft opening earlier this year, the River People Health Center held its official grand opening on May 14.

“Today, our dream becomes a reality,” said Health and Human Services Director Joseph Remitera. “This is a dream that has been over 30 years in the making.”

Salt River Pima-Maricopa Indian Community members, patients, HHS employees, Community managers and Council members gathered for the opening on a warm Saturday morning under large shaded tents with cooling fans.

Council member Tom Largo began the event with a blessing, followed by the posting of the colors by members of Salt River “Bushmasters” American Legion Post 114.

Remitera thanked all leaders, both past and present, from the Community government, the Indian Health Service and the Phoenix Indian Medical Center for making the River People Health Center possible.

“You may ask, ‘What is our why?’ Why does this center that I stand in front of exist to begin with?” said Remitera. “I believe

that our ‘why’ was best stated by Dorothy Lewis, a Salt River elder. When she spoke about the Man in the Maze, she said the following words: ‘But in real life, when you look at the maze, you start at the top and you go into the maze. In your life, you go up, you go down and you reach a place where you have to turn around. Maybe in your own life you fall. Something happens in your home. You’re sad, but

you pick yourself up, and you go on through the maze and you go on and on and on.’”

Remitera continued, “Well, that’s what we’re trying to do [here] and at all other healing centers in the Community.”

SRPMIC President Martin Harvier closed out the grand opening by remembering all of the previous SRPMIC leaders who led the way for the opening of the River People Health

Center.

“You really have to pay gratitude to the Council members who were in position through all of those [years],” said Harvier. “I know some of you have already been coming into this facility and you have seen the inside. Maybe some of you are coming in here for the first time. I hope you are amazed at the facility that’s here in our Community.”

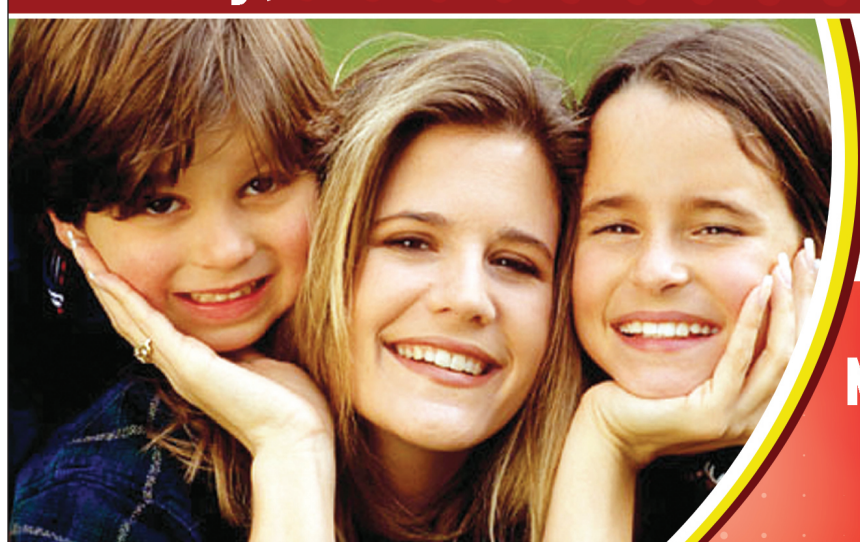

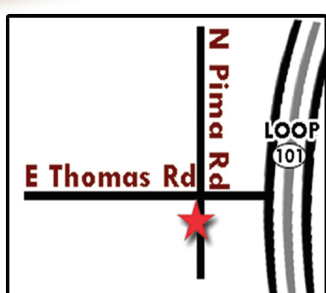

# SRFD LEGACY BURN ENDS LIVE BURN TRAINING FOR SRFD RECRUITS

The Salt River Fire Department held its final live burn, the Legacy Burn for its nine fire recruits, on Friday, May 20, at the Tempe/APS Joint Fire Training Center.

The Legacy Burn is meant to put firefighter recruits in a real-life scenario. It offers the opportunity for academy recruits to enter a burning building, rescue a victim, and then go back and put out the fire. Some recruits are accompanied by their family members who are also firefighters.

"We have recruit Ramo Wood, whose father is Deputy Fire Chief Tsosie Wood," said SRFD Fire Captain Chris Macchiaroli. "Deputy Chief Wood will do the live burn with Ramo."

During the training, SRFD recruits entered a two-story building that is

specially built to withstand the heat of a fire. Inside, a metal basket is filled with wood and lit on fire by SRFD, Superstition and Mesa firefighters after each recruit has had their turn putting out the fire.

"Each recruit had the opportunity to be on the nozzle of the hose and be a backup person that helps with carrying the hose. In some cases, for instance recruit Wood, [there will be] a third person going along with him, his father Deputy Chief Wood," said Macchiaroli. "There will be a safety officer and an instructor that will go in with each recruit at all times."

The recruits situate the water hose, break down a door and enter a burning building with temperatures of 500 to 800 degrees. Each recruit makes their way through the building and finds a victim, pulls that victim out to safety, and proceeds back into the building to put out

the fire. A recruit should take about eight minutes to get through the course. Since starting the academy, the recruits have participated in more than eight live burn sessions.

After 10 years, Deputy Chief Wood put on his firefighter gear to participate in the Legacy Burn with his son.

After taking his turn and having his father by his side, recruit Ramo Wood said, "It was fun. I had the normal nervousness of training in the fire, and plus the stress of having my role model there. I was really trying hard not to mess up, but I thought I did okay."

The SRFD recruits will complete their academy training and graduate early this month. The SRFD is seeking more recruits this summer to start the fall academy session. To apply, go to [www.governmentjobs.com/careers/srbmic](http://www.governmentjobs.com/careers/srbmic).

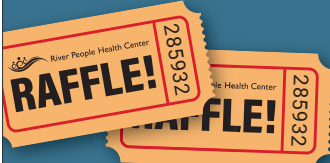

## SRPD Welcomes Three New K9 Officers

The Salt River Police Department has three new K9 officers that are trained in drug detection and criminal apprehension.

Once marijuana became legal for non-native people, it drastically limited the SRPD's K9 use with non-native people, and so the previous K9 officers cannot be used anymore. The previous K9 officers were sold to other law enforcement agencies at the San Carlos Apache and White Mountain Apache tribes or have been retired to live with their handlers.

The new K9 officers are all from the Belgian Malinois breed. Rex is 18 months old and was born in Russia and raised in Germany. He understands German and Greek. Bronson, a 2-year-old born in the Netherlands, understands Dutch and German. Perry, a 2-year-old born in France, understands French. The K9s do not have any English commands that they respond to.

Barklee, a yellow lab K9 officer, remains on duty with the SRPD as a single-purpose drug dog, which means that it only does drug detection. A dual-purpose would mean that the K9 can detect drugs as well as performing patrol work such as locating a dangerous person.

The three new dogs will be trained in trailing and article searches in the near future. Trailing is a way for the K9s to locate people, and article searches are searches for objects that have recently been touched by people, such as a gun or phone.

According to SRPD Sgt. Christopher Morin, all of the K9 officers have different backgrounds in training prior to being purchased. "Once we place an

order, they are trained in the basics of odor detection and apprehension by our trainer," said Morin. "We then complete an eight-week school as a K9 team. At the completion of the schooling, we have to pass the K9 school certification and a national certification through the National Police Canine Association. We will have to certify through the NPCA annually. We also conduct a minimum of 16 hours of K9 training a month, which is the industry standard."

The SRPD handlers will be Sgt. Morin, Off. Evan Hotchkin and Off. Drew Musacchio. The Belgian Malinois breed is known for its determination and dedication to work and the strength of the bond it forms with its human partner.

Morin wants to remind the Community that the K9 officers are not pets and are not treated like pets. They have limited interaction with the public and even the handlers' own family members.

"Never, ever pet a police K9 officer without permission from the handler," said Morin.

# Community Breaks Ground for New Mesquite Trails Rentals

The Salt River Pima-Maricopa Indian Community's Community Development Department broke ground for 18 new two-bedroom, two-bathroom housing units located east of the Canalside Homes. The groundbreaking was held on Saturday, May 14, and featured an opening prayer by Council member Michael Dallas.

CDD Director Stacey Gubser provided a brief history of the area where the new rentals are located.

"About 20 or 25 years ago, this neighborhood started out with some funding that we received from the state housing department called low-income tax credits. That brought an outside investor to bring in about \$6 to \$8 million to build the first 60 homes out here," said Gubser. "We then received a grant from HUD (the Department of Housing and Urban Development) to build the infrastructure for Canalside III and IV, which is now called Mesquite Trails. We received another grant from HUD to build a neighborhood center and young adults' transitional home. Outside funding to plant the seeds for this neighborhood was about \$12 million of other people's money to help launch this and bring Community investment for the future of the Community's young people and families."

SRPMIC President Martin Harvier gave a welcome address and explained that these homes are providing more members of the Community the opportunity to get housing.

"[A] Community survey ... revealed the need for [additional] housing," said Harvier. "We need more units [for people] to live in. I appreciate staff for the

work they're doing to get these projects going. Also thank you to Council, who has made it a priority to put housing on the top of the list for our Community members."

David Dallas of MayDall Construction, LLC, will be the contractor on this project. Dallas and the MayDall team have assisted with the construction of a number of buildings in the Community, including the Cultural Repository, Police Evidence and Storage Facility, Way of Life Facility, Scottsdale Auto Show and the Water Treatment Facility.

Council Representative David Antone commented on the efforts to provide more housing in the Community.

"It takes everybody involved to get this task done, and I think everyone who is here has had a part in getting this done—MayDall [Construction], along with President Harvier, Council members Wi-bwa Grey and [Michael] Dallas," said Antone. "When I came on Council in 2014, housing was always an issue, but it's getting done all these years later."

The rent on the new units will be set at Community market rates because the units are being added to an existing subdivision. The construction period will be 16 to 18 months.

The Mesquite Trails housing project is one of four groundbreaking events that took place during May. There will be an expansion on Lonely Cactus, adding six new two-bedroom, two-

bathroom units. There will be 14 new two-bedroom, two-bathroom units for the PALS (Social Services Young Adult Program) and Transitional Housing and Temporary Housing with 31 single and double tiny living units.

“[The SRPMIC teens] were awarded honorable mention for the Physical Health category, winning \$100. We are proud of team Salt River Pima-Maricopa Teens!” said HealthCorps Regional Program Manager Taneesha Watson.

Angela DiCicco, teen development specialist for the Boys & Girls Clubs of Greater Scottsdale Red Mountain and Lehi branches, said she is also very proud of the project that the group put together and hopes it will create lasting change in the Community.

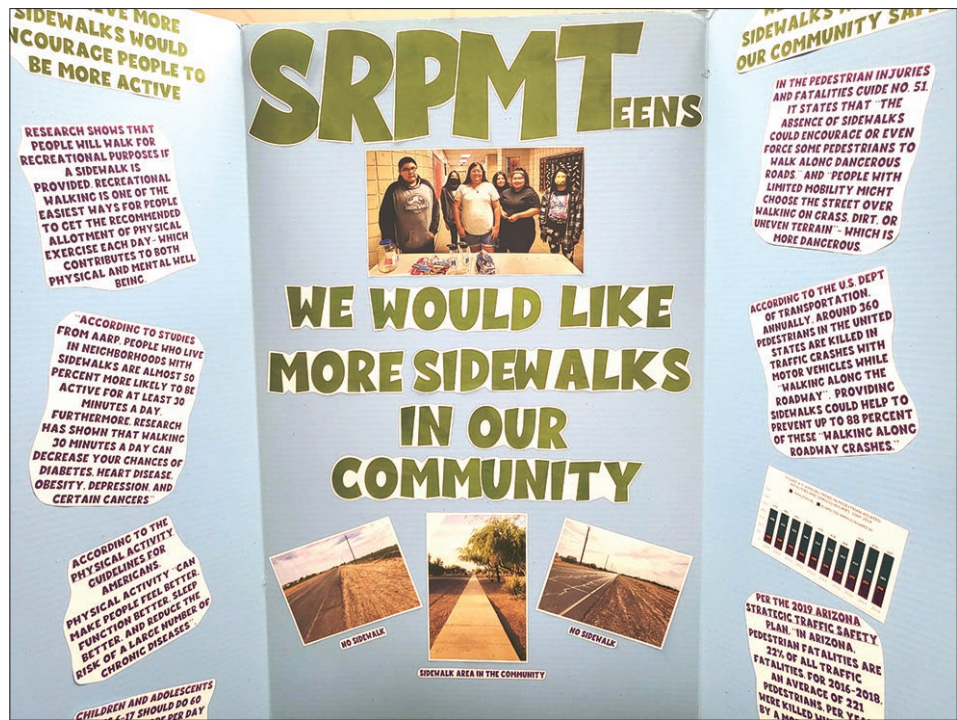
“A project like this means exposing our Community teens to healthy life choices and giving them the support and resources they need to try to make

their community healthier as well,” said DiCicco.

Voting for the National Project Health Showcase People’s Choice Award, which included the SRPMIC teens’ project, ended on May 22, and winners will be revealed at a later date.

The program provides grant funding so the teens can put their ideas into action. The team whose project receives the highest number of votes will receive access to \$500 in Project Health funds, and three runners-up will receive access to \$300 to go toward their project initiative.

“With the funding, the SRPMT team would like to continue their campaign to bring more awareness about their concern to the Community,” said Watson.

“We decided to do the project because people will walk through fields and in dirt areas where there could be snakes and rats if they don’t have sidewalks available,” said teen participant and current Jr. Miss Salt River Robin Ramirez.

Participant Domingo Pedro said that the teens also noticed that only Community areas with larger buildings, or the housing communities, have sidewalks.

“Where I live, [there are no sidewalks],” said Pedro. “The sidewalks would help me and other Community members be healthier and safer.”

The teens set up a booth at both the Lehi Club and the Way of Life Facility to distribute information about their project and conduct surveys to see how the Community feels about the topic.

On May 7, the teens submitted their proposal for inclusion in the HealthCorps National Project Health Showcase, in which students from across the nation presented ideas and

For the past couple of months, 13 teens from the Lehi and Red Mountain branches of the Boys & Girls Clubs of Greater Scottsdale have been working with the nonprofit organization HealthCorps on a project in a program called Teens Make Health Happen.

The Teens Make Health Happen club provides educational leadership programming and service learning for teens centered around physical activity, nutrition, mental resilience and community engagement.

The teens had to come up with a project to improve the health of residents in the Salt River Pima-Maricopa Indian Community. They came up with the idea to raise awareness about the benefits of having more sidewalks in the Community to both encourage exercise and improve safety for Community members.

Stay hydrated ahead of the heat by drinking plenty of fluids, preferably water.

Never leave people or pets inside a car.

Check on family members and neighbors.

Avoid strenuous outdoor activity. Watch for signs of heat exhaustion, heat cramps and heat stroke.

Recognize heat-related illness early and seek medical attention for those who experience severe symptoms.

With temperatures rising in the valley and Salt River Pima-Maricopa Indian Community, your Emergency Management team would like to share some information on heat safety. Keep in mind that everyone can be vulnerable to heat, but some more than others. Those who are most vulnerable include young children and infants, older adults, pregnant women and people with chronic medical conditions. Additional measures can be taken to ensure that these members of our Community do not fall victim to heat-related illness.

Being aware of the risk factors and following these tips can help keep individuals and their families safe when extreme heat threatens:

## Gardening Tips For June Weather

The spring planting season has already come to pass, but Salt River Pima-Maricopa Indian Community gardener Jacob Butler has a few tips to help you maintain your garden as the heat from the summer is arriving soon.

- Make sure that you are thinning your plants. A lot of times we plant multiple seeds in the garden of a single plant in a single spot. In order for that plant to reach its full potential, you have to give it the space that it needs. You don't want to pull them. You want to use your fingernail to clip the weaker plant out so you don't shock and kill the stronger plant. With many plants, you can use the edible seedlings you pull as microgreens.
- If you haven't planted yet, don't fret. In Arizona, you can plant something every day of the year. Do some research to see when certain plants are in season to plant. One of the best resources that the Community Garden uses is the University of Arizona's Cooperative Extension planting calendar, which you can find here: <https://acis.cals.arizona.edu/docs/default-source/agricultural-ipm-documents/vegetable-ipm-updates/2018/az1005-2018.pdf>
- When you're planting corn, a lot of people only plant a row of corn. But the pollen in the tassels needs to fall in the silks of the corn cobs. If not, you have missing kernels. Corn is meant to be planted in groups. In your home garden, you want to plant corn in a square of many rows or in a cluster.
- Play with microclimates. Find places in your home or yard that will

prolong the coming of the season or extend a season. It might be really hot outside, but if you're on the north side of any structure, it's going to be colder than the south side. You can get away with planting things out of season, like cooler weather plants. Use the east or south side of your house for full day exposure to the sun. You will want to avoid planting on the west side of your house because there is no morning sun, the most extreme sun exposure happens in the afternoon.

tect others and strength in spirit to lead others. I ask for dedication, dedication to my job, to do it well, and dedication to my community to keep it safe. Give me, Lord, concern for others who trust me and compassion for those who need me. And please Lord, through it all, be by my side. Amen.

After the prayer, Salt River Pima-Maricopa Indian Community President Martin Harvier and Vice-President Ricardo Leonard shared some remarks.

“I am grateful for this opportunity to say a few words, standing before you knowing that our brothers and sisters of law enforcement are remembered today,” said Harvier.

He explained that he recently walked through the Peace Officers Memorial at the Arizona State Capitol, and as he left he took the time to find the names of SRPD fallen officers Jair Cabrera and Clayton Townsend.

Off. Cabrera was shot and killed while making a traffic stop on the Community. He was 37 years old and had served with the SRPD for seven years. Off. Townsend was struck and killed by a vehicle while making a traffic stop on the Community. Townsend was 26 years old and had served almost five years with the SRPD.

“I am grateful to be part of this event, to say that today we remember and will never forget Officer Cabrera and Officer Townsend for paying the ultimate sacrifice in providing that protection and safety to the members of our Community. And as tragic as those events [are], we learn from those tragedies, and in learning hopefully things like this won’t happen again. But we know we cannot [let] our guard down. To you men and women serving as officers of this Community, we are grateful for the example you have set and we are grateful for the leadership,” said Harvier.

He concluded by saying that he truly believes when we leave this world and when we go to the other side we are not alone. He then read a poem by Robert Longley titled “A Hero’s Welcome.”

“For many years we have attended this event to memorialize the officers who have passed. It’s always

heartbreaking that there are more [law enforcement officers] throughout the nation who are losing their

lives,” said Leonard. “I want to thank the [Salt River] Police Department for their dedication to the Community. It’s hard to lose two of our own; nobody in the Community would expect these types of things to happen. Whether they say it or not, whether they express it or not, our people are very humble and happy that you are out there [to answer] the call of duty and the work that you do. On behalf of the Community, thank you very much.”


“On behalf of the 258 men and women of the Salt River Police Department, we appreciate your attendance today and your support,” replied SRPD Chief of Police Karl Auerbach.

“As we know, our Community, state and nation are protected by men and women who have sworn a holy oath to proudly take a stand, to serve, and to protect. We know these heroes as our public safety, our police, our fire, our department of corrections and also our armed forces,” said Auerbach. “We honor these men and women, their lives and their service, and their final act on this Earth; police officers, the guardians of the people. Yet we also must remember how they lived and must never ever forget their ultimate sacrifice. Please keep all of our Salt River police officers, our hometown heroes, in your daily prayers.”

Since 1791, more than 22,500 law enforcement officers have died in the line of duty in the United States. That total includes 120 police officers from Indian Country jurisdictions, 33 of them from Arizona. Two of those 33, officers Cabrera and Townsend, are from the Salt River Police Department.

Police Commanders Jonathan Gann, Walter Holloway, Alejandro McDaniel and Anthony Sandoval read the names of all the fallen Indian Country officers from Arizona inscribed on the Wall of Honor.

A flagpole rose ceremony was conducted. Commander Gann escorted Officer Townsend’s mother, Toni Townsend, and SRPD Communication Manager Kimberly Clark as they laid a single rose in honor of both fallen officers at the base of the SRPD flagpole. To conclude the memorial, Vice-President Leonard sang a memorial song in the O’odham language and Chief Auerbach provided closing remarks.

## Transitional Housing Breaks Ground in the Community

On May 17, the Salt River Pima-Maricopa Indian Community held the fourth new housing groundbreaking in recent weeks with the unveiling of plans for the Traditional & Temporary Housing units, which will be located at the northeast corner of the Two Waters north parking lot.

In total, there will be 31 single and double tiny living units, with the single unit measuring approximately 320 square feet and the double approximately 640 square feet.

Council members present at the groundbreaking were SRPMIC President Martin Harvier, Vice-President Ricardo Leonard, and Cheryl Doka, Michael Dallas, Diane Enos and David Antone.

Vice-President Leonard opened the event with a blessing, and President Harvier addressed what this new housing means to him.

“This development is really impor-

tant for the Community members who are on their journey to recovery,” said Harvier. “A lot of times there is nowhere for them to go when they finish their programs, and they’re put right back in the environment that put them in the condition they are in. And now on their journey, this is going to offer them a place where they can come and adapt to their new way.”

Enos said that the new housing is a welcome addition to the Community, with the housing crisis that is going on across the country.

David Dallas of MayDall Construction, the contractor for the project, spoke about the new units coming off the assembly line.

“These homes are just comfortable enough to do what you need, but they’re the right platform for this project, because you do want to get out. This is such a cool project because it is a transition option to help our Community members,” said Dallas.

The target date for completion of the project is the end of this year.

# RESIDENCY ORDINANCE – Draft

## Proposed Ordinance is Open for Public Comment Until August 10, 2022

The Salt River Pima-Maricopa Indian Community Council is currently considering the enactment of a Residency Ordinance. The purpose of the Residency Ordinance is to determine which non-members may be permitted to reside within the Community, track/monitor these non-members residing within the Community, and place requirements upon these non-members with respect to certain tribal programs like jury service (in limited cases). The following is a structural breakdown of the proposed ordinance:

Section 17-16 states the purpose(s) of the ordinance and defines certain terms.

Section 17-17 specifies the various non-members who may reside within the Community.

Section 17-18 lists the requirements for registration by non-member residents.

Section 17-19 includes civil violations for not complying with the proposed ordinance.

Section 17-20 includes the obligations of non-member residents.

Section 17-21 re-affirms the Community's ability to utilize and enforce the exclusion process.

The proposed ordinance is open for public comment until August 10, 2022, and will be discussed at Council District Meetings throughout May, June and July. The Community Council is hoping to receive Community member feedback on this proposed ordinance. #### ORDINANCE NUMBER SR-XX-2022

AMENDMENT TO CHAPTER 17, ARTICLE I, SECTION 17-16 THROUGH 17-21 OF THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY CODE OF ORDINANCES TO EXERCISE THE COMMUNITY'S INHERENT AUTHORITY TO DETERMINE WHO MAY RESIDE WITHIN THE COMMUNITY AND TO DEVELOP A TRACKING SYSTEM TO COMPILE DEMOGRAPHIC INFORMATION ON RESIDENTS OF THE COMMUNITY TO AID IN PUBLIC HEALTH AND COMMUNITY SAFETY, AND TO ENHANCE THE JURY SERVICE PROCESS.

Chapter 17, Article I, Section 17-16 through 17-21 of the Salt River Pima-Maricopa Indian Community Code of Ordinances is hereby amended to read as follows:

#### Sec. 17-16. Purpose and Definitions.

**Purpose.** The purpose of this Chapter is to exercise the Salt River Pima-Maricopa Indian Community's inherent authority to determine who may reside within the Community and to re-affirm the authority to exclude non-members from the Community when appropriate.

The purpose of the Community's compiling of non-member individuals residing within the Community boundaries is to allow the Community government to plan for the public health and safety needs, facilitate an enhanced system for jury service in the Community Court, and provide awareness to all residents within the Community.

**Definitions.** For purposes of this chapter, the following definitions apply:

**Commercial residential lease** means a business lease that provides residential services to non-Community members that has been approved by the Community pursuant to Chapter 17 of the Community Code of Ordinances or by the Bureau of Indian Affairs pursuant to 15 C.F.R. 162 and recorded in the Land Titles and Records system.

**Community** means the Salt River Pima-Maricopa Indian Community, a federally-recognized Indian tribe.

**Council** means the governing body of the Salt River Pima-Maricopa Indian Community.

**Detention facilities** are the adult detention facility and juvenile detention facility operated by the Salt River Department of Corrections.

**Health care facilities** are establishments providing residential care or treatment including, but not limited to hospitals, clinics, nursing homes, hospice care facilities, assisted living facilities, mental health treatment facilities, or substance abuse treatment facilities.

**Intimate partner** is a person who is in a social relationship of a romantic or intimate nature with a Community Member, as determined by the length of the relationship, the type of relationship and the frequency of interaction between the persons involved in the relationship.

**Community member** means any enrolled member of the Salt River Pima-Maricopa Indian Community.

**Minor children** are any persons under the age of eighteen (18) years.

**Non-member** means any individual who is not an enrolled member of the Community, including non-Indians and non-member Indians.

**Reside or Residency** means the place where a person actually lives. For purposes of this ordinance, remaining within the boundaries of the Community for longer than six (6) months triggers the requirements found in this section.

#### Sec. 17-17. Non-Members Allowed to Reside within the Community.

The following non-members are permitted to reside within the Community provided they have not been previously excluded pursuant to Chapter 7, Article III of the Community Code of Ordinances:

Current spouses of a Community member.

Widows and widowers who were married to a Community member, but whose spouse pre-deceased them.

Intimate partner of a Community member.

Parents of Community member minor children who have custody or partial custody of the Community member children.

Parent of an adult Community member.

Adult children of a Community member.

Minor children of a Community member.

Individuals who have a valid interest in real property in accordance with applicable Community and Federal laws, regulations and policy, but only on that property.

Persons eligible for enrollment in the Community.

Patients or clients of a health care facility located within the Community, who are admitted to the facility for a minimum of 24 hours.

Individuals in a Community detention facility.

Individuals residing within the Community pursuant to a valid commercial residential lease that has been approved by the Community.

Other persons authorized to reside within the Community pursuant to a Council resolution.

#### Sec. 17-18. Registration Requirement for Non-Member Residents.

All individuals permitted to reside within the Community pursuant to Sec. 17-17 and who are eighteen (18) years of age or older shall be required to register as a non-member resident with the Membership & Real Property Management Division of the Community Development Department. Registration must occur by October 1, 2022 or within six (6) months of moving to a location within the Community. Registration shall include the following information:

Name;

Date of birth;

Tribal affiliation, if applicable;

Physical address within the Community;

Mailing address;

Telephone number;

Email, if applicable; and

The provision(s) from Sec. 17-17 under which the non-member is eligible for residency within the Community.

All individuals permitted to reside within the Community pursuant to Sec. 17-17 and who are eighteen (18) years or older shall also be required to update their registration information within three (3) months of any changes to the information listed in Sec. 17-18(a) (1)-(8).

The following individuals permitted to reside within the Community pursuant to Sec. 17-17 shall be exempt from the registration requirement:

Minor children of Community members;

Patients or clients in Community health care facilities;

Non-member individuals in Community detention facilities;

Individuals residing within the Community pursuant to a valid residential commercial lease that has been approved by the Community. If the individual meets other criteria in Section II they shall be required to register.

Any information provided pursuant to this section may be used by the Community for official government and law enforcement purposes, including a determination of whether the person meets the standards outlined in Section II.

The Membership & Real Property Management Division of the Community Development Department shall be required to maintain an updated list of non-members allowed to reside within the Community. The Membership & Real Property Management Division may remove an individual from the list if they are unable to locate them for at least six (6) months.

#### Sec. 17-19. Civil Violation of Residency Ordinance.

Any individual who is not permitted to reside within the Community and does so in violation of these residency provisions shall be subject to a fine in the amount of \$1,000.00 for a first violation and subject to a fine in the amount of \$2,000.00 for a second or subsequent violation.

Any individual who is subject to and violates the residency registration requirement or fails to update their residency registration information shall be subject to fine in the amount of \$250.00 for a first violation and subject to a fine in the amount of \$500.00 fine for any second or subsequent violation.

Any individual who aids or abets in the violation of the residency provisions of this section, including the the registration requirement shall be subject to fine in the amount of \$500.00 for a first violation and subject to a fine in the amount of \$1,000.00 for a second or subsequent violation.

#### Sec. 17-20. Obligations of Non-Member Residents.

Non-member residents may be required to participate in the following Community programs, but not limited to:

Public health initiatives/programs.

Jury duty service in the Community Court.

#### Sec. 17-21. Exclusion of Non-Member Resident.

All non-Community members are subject to exclusion from the Community pursuant to Chapter 7, Article III of the Community Code of Ordinances regardless of their eligibility under these residency provisions.

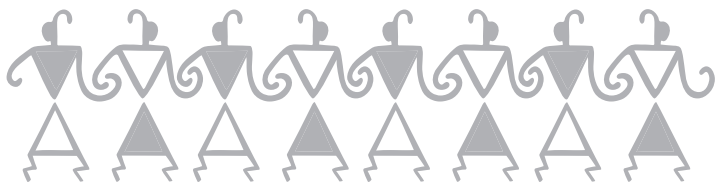

Hotels, resorts, airlines and cruise lines, for example, offer advanced bookings along with special deals and promotions from time to time that may be a lower rate than what the senior discount is. Before you book, always ask about the lowest possible rate and the best deal available.

Another way you can save is to be flexible when you travel. Last minute travel deals can offer huge savings, as does traveling during off-season or off-peak times, and avoiding holidays.

Club memberships can also garner you a wide variety of travel bargains. AARP, for example has dozens of travel discounts available on hotels, rental cars, cruises, vacation packages and more – see [AARP.org/benefits-discounts](http://AARP.org/benefits-discounts). The American Automobile Association (AAA.com) is another membership club that provides some great travel discounts to members at any age.

### Types of Discounts

Here are some of the best senior travel discounts available in 2022.

**Airline:** American, Delta and United

also offer senior fares to passengers 65 and older in certain markets but are extremely limited. And JetBlue offers 5 percent discounts for retired military and veterans that are enrolled in Veterans Advantage.

**Train:** Amtrak provides a 10 percent discount to travelers 65-plus, and a 10 percent discount to passengers over age 60 on cross-border services operated jointly by Amtrak and VIA Rail Canada.

**Rental Car:** Avis and Budget provide AARP members up to 30 percent off at participating locations. Hertz offers up to 20 off to 50-plus travelers. And Thrifty and Sixt provides 5 percent off to those 50 and older.

**Hotels:** Certain hotel chains offer discounted rates for seniors usually ranging between 10 and 15 percent off but may vary by location. Some popular hotels that offer these discounts include Best Western, Choice Hotels, Hyatt, IHG Hotels, Marriott, Omni Hotels & Resorts, Red Roof and Wyndham Hotels.

**Restaurants:** Many restaurant chains offer senior discounts ranging from free drinks, to senior menus, to discounts off your total order, but they may only be available on certain days of the week or at certain locations. Some popular options include Applebee's, Denny's, IHOP, Chili's, Perkins Restaurant & Bakery and McDonalds.

**Cruises:** Royal Caribbean and Carnival Cruise lines offer discount rates to cruisers 55 and over on select cruises. And Grand European Travel offers AARP members up to \$100 savings per person on river cruises. Call before booking to inquire.

**Entertainment and Attractions:** Most museums, zoos, aquariums, movie theaters, public golf courses and even ski slopes provide reduced admission to seniors over 60 or 65. And for those 62 or older, one of the best deals available is the America the Beautiful Senior Pass (\$20 for an annual senior pass, or \$80 for a lifetime pass) which provides admittance to more than 2,000 national parks and recreation sites.
