

## School Is Back in Session at SRPMIC

School is back in session for students at the Early Childhood Education Center, Salt River Elementary School and the Accelerated Learning Academy on the Salt River Pima-Maricopa Indian Community.

The first day of school was Monday, August 2, and classes began in-person with staff, students (with the exception of ECEC students) and visitors being required to wear masks as per federal and SRPMIC health guidelines. Staff were available to help assist ECEC students with mask-wearing if parents/guardians requested it.

Salt River Schools Interim Acting Superintendent Dr. Vicky Corlett said that SRS is staying vigilant with regard to health and safety. The protocols include taking temperatures before entering buildings, wearing face masks, respecting social distancing, and sanitizing hands, classrooms and materials throughout the day. "We are proud to offer safe, in-person learning for students and families. In-person learning is what's best in terms of learning and meeting student goals for academic progress," said Corlett.

Corlett also said in a statement on the SRS website that this school year's division-wide theme is "Reach for the Stars." On the first Thursday of every month, students and staff will be encouraged to wear their favorite college, trade school or high school gear.

"With [Reach for the Stars] we hope to recognize the dreams and goals we empower our students and families to reach, as well as to see ourselves as a constellation, a network

of shining connections in a galaxy of possibilities," said Corlett.

According to Corlett, SRS continues to offer students and families a robust academic experience beyond what other schools can offer. "Salt River Schools is unique in that our curriculum prioritizes O'odham and Piipaash languages and cultures, and we offer small class sizes for a first-class student-

teacher experience."

Many SRS events and programs are free and available to any SRPMIC student, regardless of where they attend school, including School and Community Relations, the S.T.E.P. Up Tutoring Program and many literacy initiatives, such as Footsteps2Bril-

Some people are finding it easy to move on and go back to living their lives like they did before the COVID-19 pandemic. But for others, it's a little tougher. Many people lost loved ones to COVID-19, or lost their jobs; for others, it just might have been difficult emotionally to isolate themselves from family and friends. Behavioral Health Services of the Salt River Pima-Maricopa Indian Community wants to help people get through their grief and loss so they can move on and continue to live life.

Behavioral Health Services offers a number of outpatient

services, including individual, family and couples counseling; group counseling/therapy; case management services; crisis intervention; and Community education seminars.

These programs and services include:

**Walk-In Counseling:** Same-day and next-day sessions are available, and there is no intake required for the first three sessions.

**Intake and Assessment:** Next-day appointments are available.

**Individual and Family Counseling:** There are 30- to 90-minute sessions available.

**Mindfulness Group:** Group sessions are held on Mondays

## Monsoons Bring Relief ... and Potential Damage

Every year, Arizona's monsoon season officially kicks off on June 15 and lasts until September 30. This summer's monsoon has brought plenty of rain and wind to the Salt River Pima-Maricopa Indian Community, which is precipitation that the Valley sorely missed last year. A monsoon thunderstorm can also temporarily lower the temperatures on a very hot summer day. However, the high winds and rainfall can cause property damage and even harm people and animals.

According to monsoon season station climate summaries from

the University of Arizona Cooperative Extension's Climate Science Application Program, from June 15 through August 3 this year, the Phoenix area received precipitation of 1.9 inches. A weather tracker at the Arizona State University Tempe campus shows a total precipitation of 3 inches during that time frame.

On the weekend of July 24 and 25, SRPMIC Emergency Manager Cliff Puckett said that the Community received about 4 inches of rain. Some flooding ensued in certain areas of the Community, and the Emergency Management team was on standby to help any Community



# Healthy Ways to Cope with Grief and Loss

from 2 to 3 p.m. via telehealth. This is a psychoeducation group for those 18 and older specializing in teaching healthy coping skills through mindfulness strategies.

**Teen Girls DBT Group:** Group sessions are held on Thursdays from 4 to 5 p.m. via telehealth. This is a therapy group for girls in grades 9-12; participants learn and practice skills such as distress tolerance, emotion regulation to assist in reducing self-harm behaviors, and improving relationships.

**Positive Indian Parenting Group:** This group meet on Thursdays from 12 to 1:20 p.m. via telehealth. "Honoring Our Children By Our Traditions" is a group focused on traditional parenting, storytelling, harmony in childrearing, traditional behavior modification and more.

**Children's Resiliency Group:** This group is for Salt River Elementary School children in grades K-5. Children from kindergarten through grade 2 meet on Tuesdays and grades 3-5 meet on Thursdays, at 2:30 p.m. The students learn healthy coping and social skills to increase self-esteem and better manage feelings and emotions in school and at home.

**Standard Outpatient Program (SOP):** This program meets two days a week via telehealth. It is a substance-abuse group for adults using the evidence-based modality called Seeking Safety and Stages of Change. The group curriculum addresses substance use and posttraumatic stress disorder, combining psychoeducation and process counseling.

**Intensive Outpatient Program (IOP):** The program is held on Mon-

days, Wednesdays and Fridays from 10 a.m. to 12 p.m.; it has a Talking Circle that meets in person on Tuesdays from 10 to 11 a.m. This 18-week substance-abuse group is for adults and utilizes the Matrix Model. The IOP integrates cognitive behavioral therapy, contingency management, motivational interviewing, 12-step facilitation and other elements to give clients the skills and understanding they need to overcome addiction.

**Adolescent Intensive Outpatient Program (AIOP):** This program meets Mondays, Tuesdays and Thursdays from 4 to 5 p.m. via telehealth. It is an intensive program that provides drug education and awareness, positive coping skills, sober activities, community service meetings, family education, substance-abuse counseling, and incentives and accountability.

**Aftercare Program:** Meeting on Thursdays from 3 to 5 p.m. in person, this is a substance-abuse group for adults on relapse prevention and learning life skills supportive to recovery. The group utilizes Relapse Prevention (Groski Curriculum) and Life Skills (Hazelden Reentry Curriculum).

**Anger Management Group:** This group meets via telehealth and utilizes the SAMASH workbook for anger management. Adults will learn about anger management, events and cues, anger-control plans, the aggression cycle, cognitive restructuring, assertiveness, conflict resolution and anger in the family dynamic.

**CHANGES/Batterers Intervention Group:** This telehealth group is for men and women. Men meet on Wednesdays from 6 to 7:30 p.m. and on Thursdays

from 3 to 4 p.m. Women meet on Thursdays from 12 to 1:30 p.m. This group utilizes the Duluth Domestic Abuse Intervention and Turning Points curriculum, designed to assist adult individuals to explore reasons for abusive behaviors and beliefs that support those behaviors. Participants understand the connection of painful and negative feelings to beliefs about women's and men's roles; fully explore the impact of violent and abusive behaviors on partners, children and community; and identify and practice non-abusive behaviors.

**Day Treatment:** This is offered Mondays and Wednesdays or Tuesdays and Thursdays from 12 to 2 p.m. in person. This is a psychoeducation group for adults 18 and older specializing in teaching healthy independent living skills, stress-management techniques, emotional literacy, community and connection, mental health and wellness, and medication management.

These programs and services can help people overcome mental health issues, addiction, grief and loss. Everyone needs time to mourn, but sometimes other circumstances make it difficult. If you are having difficulty grieving, contact BHS counseling at (480) 362-5707 to talk it out with a counselor in a safe place.

## Healthy Ways to Grieve

**Pay attention to your feelings:** Allow yourself to feel sadness or cry. Writing in a journal may help.

**Think about your strengths and coping skills:** How can they help you move forward? Consider previous tough transitions you've been through in your life, such as a job change, relocation or divorce. Think about what you did that helped you get through those experiences.

**Stay connected:** Use phone calls, text messages, video chats and social media to stay connected and keep in touch with family and friends who are positive and supportive. Pets can also provide emotional support.

**Create an adapted routine:** To help preserve a sense of order, in addition to your daily routine include exercise, worship or hobbies. Also, keep a regular sleep schedule and maintain a healthy diet.

**Remember the journey:** If you lost your job, don't let the way it ended define your experience. Remember the good memories and the big picture.

**Take comfort in creativity:** Start a new hobby, like cooking, gardening, painting, drawing, sculpting or whatever helps you be creative. It might help you feel better.

members in need.

"Just to put it in perspective, we receive about 8 inches of rain annually. Over that two- or three-day period, we received about half of that," said Puckett. "That's why we experienced the flooding we did that weekend."

Puckett recalled the bad floods in the Community on September 8, 2014. Four inches of rain fell that day, but it fell over a 12-hour period. The rain didn't have an opportunity to absorb into the ground and be channeled into the water systems.

The Community does have an emergency operations plan that guides all of the departments in how to respond to and recover from these large-scale incidents. Each individual department has its own internal plans.

Before the monsoon starts, Puckett said, "We have a kind of 'monsoon madness' type of meeting where we bring everyone together and review our roles as well as contact information, to make sure that the same phone numbers and people exist so that we have 24/7 ability to contact each other and implement any emergency procedures that need to take place."

When these storms have a significant impact, Puckett said that the first stage is to call the Salt River Police/Fire Dispatch alarm room. That will be the central point of contact to collect information and get services that are needed to the residents of the Community.

Heavy winds can cause power outages. If an outage lasts longer than four

to six hours and it is hot outside, the Community has access to cooling stations at the Indian School Fire Station or the Lehi Fire Station.

"We basically set up an area where Community members can cool off, get some water and snacks, get information, and we can determine if they need some additional assistance," Puckett said.


If there aren't too many Community members affected in total and the power is out or flooding causes damage to a home, the Community can provide temporary lodging. If a lot of people need assistance at once due to a weather emergency, Emergency Management has the ability to set up mass-care shelters at the Community buildings, where larger numbers of people can be accommodated with sleeping arrangements.

Sandbags are available to Community members during a flood emergency at several Salt River Fire Department stations.

# Back-to-School Drive-Thru Bash Provides Students with School Supplies

The School & Community Relations staff of Salt River Schools hosted a drive-thru event to provide Native American students with back-to-school supplies on Tuesday, July 20, at the Salt River Community Building. Families lined up to get the basics such as backpacks, paper, pencils, pens, crayons, markers, folders and all the things students need to start off the school year right.

There were enough bags for 350 students; any students who were unable to get their supplies at the drive-thru event may pick up a backpack filled with school supplies at the SRS School & Community Relations Office.

“Our whole goal is to provide support for Salt River students and families, so if they need assistance with academic support or attendance support, we’re here to help with that,” said Education Program Manager Miranda Johnson-Moya.

Supplies varied according to grade level. The event was open to all Native American students, but Salt River Pima-Maricopa Indian Community students took priority. All students were required to show their CIB/Tribal ID to receive the supplies. Unfortunately, Salt River Elementary School students were ineligible to receive supplies from this event, but they are provided with supplies when school starts.

# ‘Diabetes Among Friends’ Offers Interactive Sessions

A new series of sessions for people with diabetes is beginning on August 31. Called Diabetes Among Friends, the five-week peer-based curriculum is open to Salt River Pima-Maricopa Indian Community members age 18 and over, tribal employees, people with diabetes and caregivers of people with diabetes.

The series will take place every Tuesday and Wednesday from 6 to 7:30 p.m., with the last class on September 29.

The classes are presented over Zoom and designed to be interactive.

“We facilitate conversation surrounding topics such as getting to know diabetes, healthy eating, physical activities, medication and wellness,” said Tara

John, HHS Diabetes Services Program community health educator. “We’re opening up registration to 30 participants, who will receive a learning kit. The learning kit is a binder that contains all the PowerPoint presentations and handouts we cover in each class.”

The first round of Diabetes Among Friends was offered in June. John said the response to these classes was positive and participants offered great feedback in their evaluations.

The program involved all members of the staff, including the fitness team. Five staff are currently trained to offer this curriculum. By the end of this year, all staff in Diabetes Prevention Services will be trained in the program.

“I liked the colorful slide points and using examples of foods common to Na-

tives. The session was very user-friendly and it was easy to stay focused and involved,” said a participant on June 9.

“My Native Plate” is a colorful tool that is used as a substitute for the glycemic index, which helps people pay attention to the amount of carbohydrates they are consuming.

With My Native Plate, participants can see a visual of a 9-inch plate and learn portion control. One way to do this is to fill half of the plate with vegetables, one quarter with grain or starch and one quarter with protein. A side of fruit can also be added.

This tool shows how to incorporate traditional Native foods such as wild game, beans, nuts, squash and corn into your diet.

“I have always used a standard plate

and have always filled the plate, but when you have a smaller plate, you psych-out your mind because it makes you feel like you’re overdoing it, but you’re not. I have been using My Native Plate for a month now and have lost 12 pounds,” said a participant on August 6.

Diabetes Prevention Services also is continuing to offer weekly Zoom group workout classes led by a physical fitness specialist. If you would like to be added to the email list, contact Dion Begay at [Dion.Begay@SRPMIC-nsn.gov](mailto:Dion.Begay@SRPMIC-nsn.gov).

The first of two weeklong Journey to Wellness virtual conferences for youth, provided by Diabetes Prevention Services, will take place September 27-30. Coming up in November is Diabetes Awareness Month.


We all share moments throughout

# NARD Brings Indigenous Performers Back to Chase Field

After a year's hiatus due to the COVID-19 pandemic, Native American Recognition Day (NARD) was back at Chase Field in downtown Phoenix on July 18. Baseball fans were again able to see the best dancers and performers from Indigenous communities across the state before the game, with the Arizona Diamondbacks hosting the Chicago Cubs.


Before the dancers took the field, a variety of performance groups took turns every 15 minutes between the Sandlot and La Terraza on the upper concourse. Performers included tribal royalty, the Pee-Posh Dancers, D7 Bird Singers and Dancers, Native All-Stars, Diné Urban Voices and the Hashan-Kehk Traditional Dancers.

As the last performance group was finishing, all groups headed down to the field for a special dance across the entire outfield. Many different dance groups participated, wearing vibrant colors and traditional regalia.

One of those groups was Standing Horse Dancers, and Gabriel Scabby from the Salt River Fire Department was one of the performers.

"The Diamondbacks sent out a request for dancers to meet up and get ready to dance at the game. I believe I was the only Salt River tribal member involved with the group," said Scabby. "The Diamondbacks welcomed us early in the morning. They gave us refreshments and provided hospitality until it was time to move out to the ballfield."

Once it was closer to game time, the Standing Horse Dancers made their way

down the tunnels to right field to await the grand entry. Then, the dancers were escorted onto the field.

The starting lineup for the Diamondbacks was announced to the packed crowd, and then the announcer called everyone's attention to center field.

"The Blue Thunder drum group began singing, and we all got right into our style of dancing," said Scabby. "It felt really good to be on that stage with good friends we haven't seen in a year's

time due to COVID-19. We all enjoyed the chance to show the world that we are still here and thriving. In this day and age, it seems now more than ever we must use the opportunities to promote our Native identities with song and dance. That's why we dance—for our ancestors before us, and for those who have gone on who want us to continue the legacy that is ours."

Tribal royalty members from across Arizona were recognized along right field after the dance.

This year, NARD was presented by Gila River Hotels & Casinos and featured many members of the Gila River Indian Community before the game began. GRIC Governor Stephen Roe Lewis and Gila River Hotels & Casinos CEO Kenneth Manuel were on the field to cheer on GRIC members Michael Preston, who threw out the first pitch, and musician Adrian Thomas, who sang the national anthem in front of the color guard.

"Becoming a touring musician is my dream, and having any opportunity to perform in front of a crowd using my musical abilities is an opportunity I wouldn't refuse," said Thomas. "Not only did it help with my personal development, I went onto that field to sing the national anthem as a GRIC member and represented for the Community on a large platform."

As for the game, the Diamondbacks defeated the Cubs 6-4, thanks to a solid pitching performance by Merrill Kelly.

are confident in our processes to ensure safety and protect everyone's health," expressed Brungard.

"So, for this new school year, our focus is on the welcome. We want to be present in the moment with our students and families. We are enjoying all the energy and feelings—the buzz and hum of excitement in the air. To hear the children interacting and laughing—that felt good."

Brungard reflected on how proud she is of the ECEC staff and the relationships and trust the school builds with students and families. As a Salt River Pima-Maricopa Indian Community member, Gonzales was able to show off his talents with dance group Indigenous Enterprise at Game 5 of the Phoenix Suns' NBA Finals vs. the Milwaukee Bucks at Footprint Center on July 17.

"The performance at the Suns Finals game was more of a last-minute thing, and we didn't expect it," said Gonzales. "We did the whole thing and we got there on time, surprisingly."

But Gonzales, along with Indigenous Enterprise founder and CEO Kenneth Shirley (Diné) and the rest of the team, were up for the task, and they performed for Suns fans just outside of the court in the arena before the game.

SRPMIC music producer, DJ and dancer Tomahawk Bang was also at the performance, playing a DJ set as the group danced while fans were walking into the arena and taking photos and videos.

When that performance was over, what happened next was unexpected. The group was asked to stand behind the game's commentators on live television right before the game started.

"[The commentators] had us behind them for a good three minutes," said Gonzales. It was a very nice historical event, and it was really cool with the Suns not being in the [NBA] Championships in a while. Being a part of history. Even though they lost the finals, the Suns got that far into the playoffs.

"That was also last-minute," said Gonzales. "We got the call that morning. All of us had to run around and get our stuff and run right on over, which was pretty crazy."

The dancers on the field were all

from separate groups, performing together all at once across the outfield. This wasn't the first time Gonzales has danced at NARD, and he said he saw both new and familiar faces at the event.

Gonzales has been with Indigenous Enterprise for about four years. He said that he was taught hoop dancing at the Boys and Girls Club Lehi Branch by Kevin Dakota Duncan.


What goes into the hoop dance, like

any other powwow dance, is a lot of cardio and flexibility.

"To stretch your arms as far out as you can to make these moves work is very tough, and it requires a lot of coordination because you're spinning and running in a sense," said Gonzales. "Just to have control on your footwork and hand movements and gestures with the hoops, it's a great workout."

## WHAT IS THE DELTA VARIANT?

The Delta variant is a strain of COVID-19 that is more contagious than other strains of COVID-19.

The Delta variant spreads from person-to-person more easily, especially if a person is not vaccinated.

As of July 2021, the Delta variant has become the "dominant variant" in the United States.

The Delta variant is increasing in Maricopa County and will likely become the dominant variant.

People who have not been fully vaccinated for COVID-19 are most at risk of getting the Delta variant, and possibly becoming more seriously ill.

## HOW IS THE DELTA VARIANT DIFFERENT FROM OTHER COVID-19?

What we know, the Delta variant is spread more easily from person-to-person, which is why it is important that everyone 12 years and older get vaccinated.

There is some evidence that the illness caused by the Delta variant may be more severe, particularly in younger people, but there is still much to learn about this variant.

# Face Mask Mandate In Place Within The Salt River Indian Community Boundaries

Visitors, Community residents and members are required to wear a face mask while visiting government offices, other services, or business entities and schools, located within the boundaries of the Salt River Indian Community.

The Salt River Pima-Maricopa Indian Community would like to inform the public that a mask mandate is in effect immediately within the boundaries of the Salt River Indian Community. Patrons and guests visiting businesses in the Talking Stick Entertainment District and Pima business corridor are now required to wear a face mask.

"The Salt River Indian Community Government is requiring businesses and schools located on tribal lands that interact with the public to wear a face covering," said SRPMIC President Martin Harvier, "This is required of all individuals patronizing businesses for the health and safety of our visitors, guests, employees, and members."

On August 13, 2021, the SRPMIC Council issued a Tenth Directive – Clarification of Directives – Maintain face coverings and rescind exemptions for schools operating in the commercial corridor and businesses within the Community from the SRPMIC Directives for COVID-19 practices. Face masks are mandated within the Community and had exempted businesses in May and

schools in July that are located within its boundaries.

The Salt River Pima-Maricopa Indian Community is a sovereign nation within the State of Arizona and is not mandated to follow actions by the Arizona State Governor on facemasks. As a sovereign nation, the SRPMIC Council has the authority to pass legislation to protect its citizens and lands. Ten directives have been passed in accordance with the SRPMIC Local Emergency Declarations, "to protect and defend the health and welfare of the Onk Akimel O'odham (Pima) and Xalychidom Piipaash (Maricopa), Residents, Community Employees, Businesses, and visitors of the Salt River Pima-Maricopa Indian Community, by reducing the spread of COVID-19.

The Salt River Indian Community was seriously impacted by COVID-19 during the height of the pandemic in 2020 and is still taking the necessary health and safety precautions to protect its Community and visitors.

## ZOOM with a Counselor


We looked at our use of alcohol or other drugs to see if it has caused harm or could cause harm.

## LOCAL EMERGENCY DECLARATION \*\*COVID-19\*\*

### TENTH DIRECTIVE -AUGUST 13, 2021 CLARIFICATION OF DIRECTIVES - MAINTAIN FACE COVERINGS AND RESCIND EXEMPTIONS FOR SCHOOLS OPERATING IN THE COMMERCIAL CORRIDOR AND BUSINESSES WITHIN THE COMMUNITY FROM THE SRPMIC DIRECTIVES FOR COVID-19 PRACTICES

TO PROTECT AND DEFEND THE HEALTH AND WELFARE OF THE ONK AKIMEL O'ODHAM AND XALYCHIDOM PIIPAASH, RESIDENTS, COMMUNITY EMPLOYEES, BUSINESSES AND VISITORS OF THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY BY MAINTAINING FACE COVERINGS AND RESCINDING THE EXEMPTIONS FOR SCHOOLS OPERATING IN THE COMMERCIAL CORRIDOR AND BUSINESSES WITHIN THE COMMUNITY FROM THE SRPMIC COVID-19 DIRECTIVES.

**WHEREAS**, to protect the health and welfare of the Salt River Pima-Maricopa Indian Community (the "Community" or "SRPMIC") on March 18, 2020, a Local Emergency Declaration for COVID-19 was issued to lessen the impacts of the COVID-19 pandemic, followed by additional directives that to-date have almost all been rescinded (the "SRPMIC Directives"); and

**WHEREAS**, on January 30, 2020, the World Health Organization declared the COVID-19 virus a public health emergency of international concern and Arizona Governor Douglas Ducey declared a state of emergency for the State of Arizona on March 11, 2020 and issued subsequent directives (the "Arizona Directives") that to-date are rescinded; and

**WHEREAS**, the COVID-19 is a serious public health threat to the Community and as of August 13, 2021 the Arizona Department of Health Services and local public health departments have identified 958,992 cases of COVID-19 with 18,435 deaths in the state and within the Community 1,270 cases of COVID-19 have been identified and 41 deaths; and

**WHEREAS**, the COVID-19 vaccine is available to persons twelve years of age and older and 34% of Community members within Arizona twelve years and older are vaccinated; and

**WHEREAS**, throughout the COVID-19 pandemic the Centers for Disease Control and Prevention (the "CDC") issued health and prevention guidance that has been incorporated into the SRPMIC Directives and the Arizona Directives; and

**WHEREAS**, on July 27, 2021 issued new guidance for persons to wear a mask indoors in public, regardless of vaccination status, if in an area of substantial or high transmission. Currently, Maricopa County is at a high transmission rate for the COVID-19 virus and the Delta variant; and

**WHEREAS**, on July 27, 2021, in response to the CDC guidance, Governor Ducey issued a statement that "Arizona does not allow mask mandates, vaccine mandates, vaccine passports or discrimination in schools based on who is or isn't vaccinated. We've passed all of this into law, and it will not change."; and

**WHEREAS**, due to the conflict of CDC recommendation and Governor Ducey's statement, and to be clear of the Community's authority pursuant to the local emergency declaration process under Chapter 1, Article V, Section 1-500 of the Community's Code of Ordinances, continued measures are required to safeguard the Onk Akimel O'Odham and Xalychidom Piipaash, residents, Community employees, businesses and visitors of the Community from the COVID-19 pandemic; and

**WHEREAS**, the Community, working with its combined strength, unity and commitment, will work to protect the health and welfare of the Community against COVID-19.

NOW THEREFORE the SRPMIC Local Emergency Declaration for COVID-19 of March 18, 2020 remains in effect, and I, along with the Council, hereby issue the following:

#### Continued Practices

##### 1. The Community requires the following practices to continue:

- Wear a face covering (see below);
- Wash hands regularly with soap and water or alcohol based hand sanitizer;
- Maintain physical distancing of six (6) feet or more from persons not of your household;
- No unnecessary medium to large size gatherings (parties);
- Avoid physical contact (handshakes);
- Avoid touching your face;
- Cover your mouth and nose when coughing or sneezing; and
- Stay home if you feel unwell.

- Curfew for juveniles remains in effect per code section 11-217

**2. Businesses and schools within the Community may continue to operate within the Community as long as they are in compliance with CDC guidelines, practice social distancing, and are compliant with the SRPMIC Directives in effect.**

#### Face Coverings

##### 3. Effective immediately, all individuals who are 2 years of age or older and within the Community are

required to wear face coverings if outside of their residence and are or will be in contact with other individuals who are not from their household whether in a public place, business, restaurants, churches, schools, government facilities, or any space offered to or for use by the public. See exemptions below.

4. The purpose of these directives is to reduce the risk of exposure to COVID-19 in areas outside your residence and to protect the Onk Akimel O'Odham and Xalychidom Piipaash, residents, Community employees, businesses and visitors of this Community.

5. Businesses that interact with the public must require employees and all individuals patronizing their business to wear a face covering in public areas if they are or will be in contact with other individuals.

6. While wearing the face covering, it is essential to still maintain physical distancing as it is the best defense against the spread of COVID-19. Physical distancing means keeping (6) feet distance between individuals who are not in the same household.

##### 7. Exceptions for face coverings will be made under the following circumstances:

- For those who fall into the Centers for Disease Control and Prevention's guidance for those who should not wear face coverings due to a medical or mental health condition or developmental disability.
- For children under 2 years old.
- For restaurant patrons while they are eating or drinking. If a patron is not seated at their table, a face covering is required.
- For individuals exercising outdoors, or while walking or exercising with other people from the same household, as long as physical distancing from others is maintained. For individuals congregating outdoors with other people not in their same household, face coverings are required when physical distancing is not maintained.
- In settings where it is not practical or feasible to wear a face covering, including when obtaining or rendering goods or services, such as the receipt of dental services, medical treatments or while swimming. This exception does not extend to the entertainment setting such as bars, dance floors or any other setting where people socially congregate in public for entertainment purposes.
- When a person is in a personal or work office or vehicle (or similar space) where others are not present as long as the public does not regularly visit the space.
- For public safety employees and/or emergency responders and/or field employees engaged in essential functions, when wearing the face covering would interfere with or limit their ability to carry out their duties or functions.
- For individuals complying with the directions of public safety employees.

**8. A face covering means material that covers the nose and mouth. It can be secured to the head with ties or straps, or wrapped around the lower portion of the face. It can be homemade or commercially made and shall be worn per guidance provided by the Centers for Disease Control and Prevention. It does not include gaiters, bandanas, or wearing only a plastic shield.**

**9. Enforcement of this directive shall focus first on education and providing guidance issued by the SRPMIC Health and Human Services Department or the Centers for Disease Control and Prevention, in order to promote the health and safety of Onk Akimel O'Odham and Xalychidom Piipaash, residents, Community employees, businesses and visitors of this Community as well as to further contain the spread of COVID-19. Individuals shall also be given an opportunity to comply with this directive before any enforcement action is taken. Continued failure to comply with an emergency directive is a civil violation under Section 1-503 of the SRPMIC Code of Ordinances.**

**10. Businesses and all venues shall enforce this directive by asking any person failing to comply with the emergency directive to leave their premises. By allowing people/ patrons to remain on the premise without a face covering, as described in paragraph 1, is violation of this emergency directive. A continued failure to comply with a SRPMIC emergency directive by a business owner and/or responsible party is violation under Section 1-503 of the SRPMIC Code of Ordinances.**





## Unvaccinated, Hospitalized: Patient Now Advocates For Shots

BATON ROUGE, La. (AP) — Cedric Daniels and Joshua Bradstreet Contreras didn't think they really needed the coronavirus vaccine. After all, the uncle and nephew are both young — 37 and 22, respectively — and Contreras was "as healthy as a horse," Daniels said.

But just days after Daniels went to visit Contreras in New Orleans — a long-awaited reunion that came after not seeing each other for months because of the pandemic — the nephew was rushed away in an ambulance. He couldn't breathe, even when sitting completely still. He is now in a hospital in a New Orleans suburb, on a ventilator and in a medically induced coma.

At about the same time, Daniels started feeling weak, had blurred vision and was so short of breath he could barely make it from his couch in the living room to the bathroom. He tested positive for the virus, then went to a hospital in Baton Rouge already overwhelmed with COVID-19 patients, where he stayed for a week on oxygen as he recovered from pneumonia.

Contreras and Daniels are among a flood of patients filling up overloaded hospitals across the U.S. amid a surge of COVID-19 cases driven by the virus's highly contagious delta variant. Health officials say the most serious cases have been among the unvaccinated.

"It is frustrating, because it's preventable ... but more than that, it's really sad," said James Ford, a critical care doctor in the ICU at Our Lady of the Lake Medical Center in Baton Rouge, where Daniels was treated.

To help with the influx, the hospital brought in a

disaster medical assistance team of nearly three dozen health care workers on Monday. That same day, hospital leaders at a news conference where Gov. John Bel Edwards announced a reinstated statewide mask mandate described grim conditions across Louisiana: facilities filled with COVID-19 patients, including children, and hospital hallways lined with stretchers because there aren't enough beds.

"A lot of them are debilitated and need around-the-clock care," said Ford, who has been working on his days off to help ease his hospital's burden. "It's very labor intensive."

Some of those patients, like Daniels, now wish they had taken the shot.

"They're talking about putting tubes down your throat possibly if your oxygen doesn't go up within the next hour, and that is frightening," he told The Associated Press on Monday as he lay in a bed with an oxygen tube in his nose. He was released shortly afterward but still must use oxygen at home.

"I am now a huge advocate for doctor's orders," Daniels added. "They think we ought to get vaccinated, I think we ought to get vaccinated."

Daniels, who lives in Gonzales, about 57 miles (92 kilometers) northwest of New Orleans, said he and Contreras were the only unvaccinated members of their households. Daniels' wife and live-in mother-in-law, both of whom were inoculated months ago, have both tested negative twice since he tested positive.

Contreras' mother, Tarsha Bradstreet, had also been vaccinated, as had her 19-year-old son who lives in the same house in New Orleans. Bradstreet said she tried to

persuade Contreras to get the shot, but said she had only so much pull over him.

"Josh hardly goes anywhere since COVID hit, so he didn't think he needed the vaccine," Bradstreet said.

One of the places to which Contreras did go, however, was his summer job at Café Reconcile. About the time he started getting ill, he got a call from the restaurant telling him that a co-worker had tested positive for the virus and he needed to get tested himself.

"He had a headache and some nausea, so at first we thought it was dehydration," Bradstreet said. "A week later, he couldn't smell. He couldn't breathe. I noticed his breath was quick and rapid, and he could barely stand up or do anything. I had to call an ambulance."

A while later, the hospital called and said, "'Your son is on a ventilator,' and I almost died," Bradstreet said. "I couldn't believe it. I didn't realize how serious it was. I didn't know. He almost died."

Bradstreet talks to her son every day through one of the hospital's portable laptops, so that he can hear her voice even if he can't see her.

She also prays a lot, and hopes that sharing her son's story will motivate others who have not yet been vaccinated to go and get the shot.

"When we go through things, it's to help other people, to teach people something," she said. "Their choice may leave them in the hospital. Maybe they'll get the lesson before they have to go through this."

# How to Replace Important Documents That Are Lost or Missing

Dear Savvy Senior,

Can you tell me what I need to do to replace a variety of important documents? Our house burned down a few months ago, and we lost everything including our home property deed, car titles, old tax returns, Social Security, Medicare and Covid vaccine cards, birth certificates, marriage license and passports.

Stressed Seniors

Dear Stressed,

I'm very sorry for your loss, but you'll be relieved to know that replacing important documents that are destroyed, lost or stolen is pretty easy once you know where to turn. Here are the replacement resources for each document you mentioned.

**Birth certificates:** If you were born in the United States, contact the vital records office in the state where you were born (see [CDC.gov/nchs/w2w/index.htm](https://www.cdc.gov/nchs/w2w/index.htm) for contact information). This office will give you specific instructions on what you need to do to order a certified copy and what it will cost you – usually between \$10 and \$30.

**Car titles:** Most states offer replacements through a local department of motor vehicles office. You'll need to complete a replacement title application form and pay the application fee, which varies by state. You'll also need to show ID and proof that you own the car, such as your vehicle registration or your license-plate number and VIN (vehicle identification number). To get an application, go to [DMV.org](https://www.dmv.org), pick your state, and print it or fill it out on the site.

**Property deed:** To access your house

deed, contact your county clerk's office, where deeds are usually recorded – you may be charged a small fee to get a copy.

**Marriage certificate:** Contact the vital records office of the state you were married in to order a copy (see [CDC.gov/nchs/w2w/index.htm](https://www.cdc.gov/nchs/w2w/index.htm)). You'll need to provide full names for you and your spouse, the date of your wedding, and the city or town where the wedding was performed. Fees range from \$10 to \$30.

**Social Security cards:** In most states (except in Alabama, Minnesota, Nevada, New Hampshire, Oklahoma and West Virginia), you can request a replacement Social Security card online for free at [SSA.gov/myaccount](https://www.ssa.gov/myaccount).

If you live in a state that the online service is not available, you'll need to fill out form SS-5 (see [SSA.gov/forms/ss-5.pdf](https://www.ssa.gov/forms/ss-5.pdf) to print a copy) and take it in or mail it to your nearby Social Security office along with a number of evidence documents that are listed on this form. For more information or to locate the Social Security office that serves your area, call 800-772-1213 or see [SSA.gov/locator](https://www.ssa.gov/locator).


**Medicare cards:** If you are enrolled in original Medicare, you can replace a lost or damaged Medicare card by calling Medicare at 800-633-4227, or by logging into your MyMedicare.gov account. If, however, you get Medicare health or drug benefits from a Medicare Advantage Plan, such as an HMO, PPO, or PDP, you'll need to call your plan to get your card replaced.

**COVID-19 vaccination card:** Your first step is to go back to your vaccination site and see if they'll give you a replacement. Bring an ID and try to recall the date you were vaccinated. If that's not feasible, contact your state health department immunization information system (see [CDC.gov/vaccines/programs/iis/contacts-locate-records.html](https://www.cdc.gov/vaccines/programs/iis/contacts-locate-records.html)) where you should be able to print out a replacement sheet. (See *ad on page 14*.)

**Tax returns:** To get copies of old tax returns start with your tax preparer, who usually keeps copies of your returns on file. You can also get copies of federal returns directly from the Internal Revenue Service. You'll need to fill out and mail in IRS form 4506. To download this form [IRS.gov/pub/irs-pdf/f4506.pdf](https://www.irs.gov/pub/irs-pdf/f4506.pdf) or call 800-829-3676 and ask them to mail you a copy. The cost is \$43 for each return requested.

**Passports:** You can apply for a replacement passport at a Passport Application Acceptance Facility. Many post offices, public libraries and local government offices serve as such facilities. You can search for the nearest authorized facility at [iafdb.travel.state.gov](https://iafdb.travel.state.gov). The fee is \$145.

This letter is to provide you with official notice that on Wednesday, July 14, 2021, the Salt River Pima-Maricopa Indian Community (“Community”) Council decided pursuant to Article VII, § 1(g) of the Community’s Constitution, § 7-75(e)(4) of the Community’s Code of Ordinances, and Community Resolution SR-2388A-2004 to temporarily exclude you, as a non-member, from the boundaries of the Community. Your presence in the Community is determined to be a present and substantial danger in regards to allegations of illegal dumping, trespass, suspected drug use, and other illegal activity.

**Based upon this temporary exclusion, you are to immediately leave the boundaries of the Community, you will not be allowed to be within the territorial boundary of the Community and therefore, you are not allowed to drive through, visit others, reside or come within the Community’s boundaries at any time for any reason.**

Finally, the Council has also initiated the process to permanently exclude you from the boundaries of the Community. Please expect to receive notice of an upcoming hearing before the Community’s Exclusion Committee regarding the request to permanently exclude you from the Community’s boundaries. If we are unable to locate you, notice of the hearing will be placed in the Community’s newspaper at the Arizona Business Gazette.

Any violation of the temporary exclusion set forth in this letter will be enforced by the laws of the Community by the SRPD.


