The Salt River Pima-Maricopa Indian Community celebrated Native American Recognition Days on October 1 at the Two Waters Courtyard. The event included art demonstrators, performances and social dancing throughout the evening. The event was delayed a week because of weather.

The evening started off with a welcome and blessing from Salt River Royalty, Jr. Miss and Miss Salt River Teegan Smith and Mandree Jose. A dinner of red chili stew and three sisters salad was offered to the first 700 guests; all guests received a promotional item giveaway.

The first performance of the evening was from Community member and hoop dancer Jorge Gonzales, who shared a descrip-

tion of his dancing. Gonzales is the current Mr. Indian Scottsdale Community College. "The hoop dance I will be doing is a healing dance used to help those who may be sick or weak. It is to transfer the dancer's energy to those in need," Gonzales said.

Right after that, a Polynesian dance presentation by Na Leo Kupono Productions got everyone's attention as a duo performed several dances from

the Pacific Islands, including an exciting fireknife dance.

As the sun went down, O'odham and Piipaash social dances took place side-by-side, presented by the SRPMIC Traditional Dancers and Singing and Dancing by The River.

Toward the end of the evening, the Cruz Band played a chicken scratch dance, and many of the guests danced to every song they played.

The entire department now takes over half of the former Community Service building (located behind the Cultural Resources Department in the government complex). AZ State Democratic Senate Candidate Mark Kelly Visits SRPMIC Council

Retired United States Navy pilot, engineer and NASA astronaut Mark Kelly sat down with the Salt River Pima-Maricopa Indian Community Council to discuss the issues facing Indian Country and to build a relationship with all Arizona communities as he gears up for the 2020 U.S. Senate special election in Arizona.

The senate seat was occupied by the late John McCain for years until his death in 2018. Arizona Gov. Doug Ducey appointed Republican Martha McSally to fill McCain's remaining term.

Since he announced that he was running for the Senate seat eight months ago, Kelly has been traveling across the state to find out what issues are affecting the people of Arizona.

"We have a goal to visit all 22 tribes in Arizona, and maybe more than once. I am here today to learn about how the SRPMIC is dealing with the federal government so that if am elected, I will be prepared when I get to Washington D.C. to better represent everyone in Arizona, including this Community."

SRPMIC President Martin Harvier expressed his gratitude for Kelly's interest in visiting the Community. He explained that the Community has always welcomed state and national leaders to visit and learn about our Community.

"Our community has been blessed here because of our location, but we still have a need to provide for our members when it comes to government funding," said Harvier.

The SRPMIC Council welcomed Kelly, discussing issues facing the SRPMIC and other Arizona tribes on the topics of voting, healthcare and education. The Council explained to Kelly that one of the most pressing issues is the drug issue, particularly heroin, fentanyl and carfentanil. The Community's Anti-Drug Awareness Campaign and Narcan training are two ways that the Community is combating this issue. Cut-through traffic in the Community also plays a part in

the drug problem.

The Council discussed moving forward with the new ambulatory healthcare facility; they want to make sure the Community and the government are on the same page when it comes to funding and staffing of the facility.

Other topics included Salt River Schools and the danger of the high school closing due to low test scores; land development; and how the Community is self-sufficient, with limited funds coming in from the federal government.

"The Community government provides 85% of the funding it takes every day to run this Community year-to-year from the Community's businesses that they own and operate," said Community Manager Bryan Meyers. "We are willfully underfunded by the federal government."

Their final discussion was on the 2020 election and how the Community encourages its members to

register to vote.

Council Member Thomas Largo asked Kelly if he were elected how he would represent Arizona. "We need someone who is going to represent the people of this state and put them first, because nothing is getting done right now," said Largo.

"When my wife [former U.S. Rep Gabby Giffords] was in the House [of Representatives], The National Journal used to rank people on the left and on the right. In her second term in office she was one of the people in the middle or next to the middle, and as a Democrat, she was more conservative than the Republicans—there were Republicans to the left of her," said Kelly. "That doesn't exist anymore in [Congress], and we have to get back to that because that promotes cooperation. I will be a person looking to work across the aisle."

Giffords represented Arizona's eighth district from 2007 to 2012.



Electronic Cigarette Facts

according to reports.

A National Institute on Drug Abuse survey of eighth-, 10th- and 12th-graders revealed high rates of vaping in 25% of seniors, 20% of sophomores and 9% of eighth-graders in the past month.

One company, JUUL, has come under fire for its ad campaign targeting young smokers and for its small vaping device, similar to a USB flash drive, that is easily concealed.

In late September, the CDC reported that 805 people from 46 states have been diagnosed with vaping-related lung injuries since April. Twelve deaths have been confirmed in 10 states, according to the CDC. All patients reported a history of e-cigarette product use.

The CDC data revealed that 62% of the patients were age 18 to 34 and 16% were younger than 18.

A recent study by the Mayo Clinic

revealed that chemical fumes, not oils, may be to blame for the lung illnesses.

The U.S. government is looking at policy and a potential ban of non-tobacco-flavored products. Some states are banning vaping devices or restricting flavoring. San Francisco banned the sale and distribution of vaping devices, according to USA Today.

At least one tribal community has banned e-cigarettes: The Oglala Sioux Tribe has banned the sale, possession and use of e-cigarettes on the Pine Ridge Indian Reservation.

SRPMIC Board Opportunities and Benefits

Each month, a list of vacant seats on Salt River Pima-Maricopa Indian Community boards is mailed to each Community member to give them an opportunity to apply for those board seats and help make decisions that benefit the best interest of the SRPMIC and its members.

Community Council Executive Secretary Erica Harvier keeps track of each board vacancy and ensures each board seat is filled.

"Each month I post the list of board vacancies through sending it out to all Community members through the Human Resources Digital Signage, Announcements and O'odham Action News. I also place hard copies of the announcements in the Council Chambers," said Harvier.

Those interested in filling a vacancy on a board fill out and submit an application. There is one basic application for all boards except for the Education Board, Law Enforcement Commission and Judicial Committees, which have a more extensive application process. For each vacancy, Harvier prepares an information packet for Council to review. It includes the board vacancy information, information about the board's work and the ordinance, and the application forms from the people who have applied for that vacant seat.

Once Council reviews the packets and approves the applicants, the packets go on to the board itself so the board members can review the applicants and provide a recommendation to Council regarding who they feel is the best candidate, explained Harvier. "Council

usually wants a recommendation from the board," she said. After the board sends its recommendation letter, Harvier will include that letter in the packet she resubmits to the Council for a final approval of their selection in the regular Council session.

The Council can go with the board's recommendation or it can move to appoint a different candidate, explained Harvier. Once the applicant is chosen, she sends a letter informing them that they are selected and whom to contact on the board for further information. She also sends a letter to the applicants that weren't chosen and encourages them to continue to apply for the same board or a different board. Finally, she sends one more letter to the board to let them know which applicant has been chosen to fill that board's empty seat.

Each board is different in terms of positions and terms. For example, there are professional and/or Community-member board seats, but boards such as the Law Enforcement Committee have positions such as a youth representative, a senior representative and a Lehi representative. Board members can have three- or four-year teams.

Having longer terms "helps [board members] get in there and feel like they had some time to learn about the board and the issues of that board," said Harvier.

There are popular boards and unpopular boards. Harvier receives a high number of applications for certain boards, such as the Gaming Board, and very few for non-paying boards. For a popular board, once she announces the vacancy, she immediately receives many applications. For other boards, she'll have to make more than one announcement before she gets enough

applicants for consideration.

For example, "If we get only two applicants, Council will want more applicants [than that], so we will open it back up."

An individual can serve on no more than two boards at a time. This was ordered by Council to keep it fair for others who want to participate on the boards. If you want to apply for a board seat, it is always helpful to have knowledge or experience in the area that particular board deals with.

Currently there are 92 people, including Council representatives, serving on Community boards and/or Enterprise boards. The purpose of the boards is to help Council delegate the work.

Harvier explained, "An example would be Donation Committee. A lot of requests [for donations] come to the Community because we are a gaming tribe. Rather than spend time reviewing all the requests for donations that come in, Council has bigger issues to deal with. So, they created the Donation Committee to review the requests for funding, and if they feel that the request meets the Council's guidelines, the board can act on behalf of Council and recommend the request. They are doing the legwork of Council, making recommendations and keeping Council apprised on board issues."

StrongLife Community Wellness Program Update

On Tuesday, October 1, Community Wellness Manager Toni Harvier presented an information session for Salt River Pima-Maricopa Indian Community members and their families about the StrongLife Community Wellness Program.

The program is designed to give SRPMIC members the opportunity to start a "wellness journey" built around five themes: family wellness, financial wellness, physical wellness, cultural/social wellness and emotional/spiritual wellness. StrongLife works by awarding points for completing the activities in any of the five themes. Participants can redeem their accumulated points for incentives such as movie tickets, massages, workout equipment, clothing, event tickets and gift certificates.

Community members may earn up to 100 points in each theme, with the exception of physical fitness, which is worth 150 points because there are more opportunities in the fitness area. Two particular program activities can get you major points: biometric screening and achieving your personal wellness goal. Both are worth 100 points by themselves.

A total of 600 points are awarded for the calendar year. Participants can earn points by participating in recommended activities or Community events that carry the StrongLife logo. To prove points have been earned, participants provide photographic proof of attending/participating in activities to the Community wellness manager, either through email or in person during monthly check-ins.

StrongLife works by awarding points for completing activities (see sidebar for activities) in any of five wellness themes.

Family Wellness

Family Wellness activities work toward enhancing the quality of daily family life, as well as togetherness and gratitude for each other.

Financial Wellness

Financial Wellness entails planning for financial security, controlling your spending and maintaining skills for financial stability.

5 Wellness THEMES

Physical Wellness

Physical Wellness helps members to see fitness and nutrition as the core for good quality of life for oneself and posterity with a focus on living and enjoying life.

Cultural/Social Wellness

Cultural/Social Wellness cultivates pride in true identity, desire to learn about our culture, love the land and people, and to hold on to our traditions and sovereignty.

Emotional/Spiritual Wellness

Emotional/Spiritual Wellness is a

personal acknowledgement of connection to a higher power, strength and healing in mental stability.

"This program is a great opportunity, because ... this program is specific for SRPMIC members and their immediate family members (children, spouses who are not enrolled in SRPMIC)," said Harvier. "You think about [wellness] and talk about it, wanting to live a healthier lifestyle, and now the Community is offering those who commit to wellness [the chance to earn incentives] in any of these five themes."

The StrongLife Community Wellness Program is open to all SRPMIC members and their immediate family members ages 5 years and older. To join the program, check the calendar for upcoming informational meetings or call (480) 362-6995 to register and pick up a wellness journal. Begin with any of the five themes (see sidebar) and track your activities.

National Native American Veterans Memorial Breaks Ground

Warriors' Circle of Honor, a National Native American Veterans Memorial in Washington, D.C., broke ground on September 21.

The groundbreaking brought out tribal leaders from across Indian Country, including U.S. Rep. Deb Haaland of New Mexico.

The Smithsonian National Museum of the American Indian held the groundbreaking, and the memorial will be the first of its kind on the National Mall. The memorial is expected to be completed by Veterans Day 2020.

Deer was selected by a nationwide panel of judges for her work on the Violence Against Women Act and the Tribal Law and Order Act, according to Indian Country Today.

Deer is an author and a law professor at the University of Kansas.

Ponca Chief Standing Bear Statute Unveiled in Washington, D.C.

In September, a bronze statue of Ponca Chief Standing Bear was unveiled at the Capitol Visitor Center at the U.S. Capitol in Washington, D.C.

Standing Bear, a civil rights giant and leader, will represent Nebraska. Each state can select two statues for permanent display in the Capitol. Standing Bear replaces Nebraska politician William Jennings Bryan and became the newest Indigenous person to have a statue in the U.S. Capitol.

Others include Sequoyah, representing Oklahoma; Eastern Shoshone Chief Washakie, representing Wyoming; and a handful of others.

SRPD Safety Reminder For "Stranger Safety"

in doing so can lure your children out into the open or place them in compromising positions.

What is a safe stranger? Safe strangers are people your children can turn

strangers for help.

Salt River Police Department School Resources Officer (SRO) Cpl. Spencer Stant makes the following recommendations:

- Student safety on the way to and from school is a priority. If a family member, friend or other person is tasked with picking up a student, and that student may not know or be unfamiliar with that person, come up with a code word or phrase. Have your child ask the person for the code word. If it is not the proper code word or phrase, your child should refuse to go with that person.
- If the person does not have the code word, tell your child to inform the nearest adult, or go home immediately and tell a parent or adult family member. Always call the police and report what happened.

SRPD Public Safety Dispatch Supervisors and Officers Earn Lifesaving Award

On September 18, at the Salt River Pima-Maricopa Indian Community Council Meeting in Lehi, Salt River Police Department Public Safety Dispatchers Chaela Jepsen and Kayleigh McCoy and SRPD Police Officers Zachary Favela and Jonathan Portillo received the prestigious Lifesaving Award from SRPD Chief Karl G. Auerbach. Witnessing the event were SRPMIC Council, Community members, staff and guests.

On August 12 at about 4:20 a.m., SRPD police officers were dispatched to a Community residence in reference to an adult Community member who was unresponsive and not breathing as the result of an overdose.

Dispatcher Chaela Jepsen took the initial 911 call. She obtained details from the caller about the patient and immediately entered a Salt River Fire Department EMS call for service. Meanwhile, Dispatcher Kayleigh McCoy coordinated the SRPD call for service and had police and fire units dispatched within 30 seconds.

Until SRPD police officers arrived on scene, Jepsen provided the caller with continuous pre-arrival medical instructions, encouraging the family to perform CPR.

SRPD officers Jonathan Portillo and Zachary Favela arrived within 1 minute and 55 seconds after being dispatched. They ran inside the residence, found the Community member lying on the floor, and determined that she was not breathing and had no pulse.

Off. Portillo immediately initiated CPR while Off. Favela administered one application of Narcan to the victim. CPR continued, and a second application of Narcan was given.

As SRFD professionals arrived on scene about 1 minute later, officers Portillo and Favela had successfully established a good heartbeat and the victim began to breathe on her own. SRFD transported the victim to a local hospital, where she made a full recovery.

After the Lifesaving Award presentation, SRPMIC President Martin Harvier commented very positively upon the actions of the SRPD team members, who were joined at the presentation by SRPD command staff and family.

“Dispatchers Chaela Jepsen and Kayleigh McCoy followed their dispatcher training, experience and skills ... [and] upon the rapid arrival of Off. Jonathan Portillo and Off. Zachary Favela, who continued CPR and deployment of Narcan, the combined teamwork actions resulted in the saving of this Community member’s life,” said Chief of Police Karl G. Auerbach. “Our Community and the SRPD are so very fortunate to have such dedicated and proficient public safety professionals protecting our Community. We are very proud of them and so glad they are on the SRPD Team!”

struction Project Supervisor Tommy Gardner.

“This particular project, because of their trade and experience, we didn’t let it go out to a general contractor; [SRPMIC] Public Works was the acting general contractor,” said Public Works Senior Project Manager Jeff Rind. “The Apprenticeship participants did all the demo work, framing, drywall, painting and flooring. These Community members of the Apprenticeship Program did about 85% of this project. I am very proud of these guys.”

Hudson also thanked Facilities Coordinator Linda Eckstein for that group’s expertise and work to get the project finished. Also recognized was the Information Technology Department staff for connecting the electronics systems throughout the building.

“We are very appreciative, and I know our customers are appreciative. Where we are to now is night and day. This is our day to thank you all for all that you have done,” said Hudson.

The Social Services Department provided tours to those who wanted to see the changes that were made to the building to better help accommodate the staff and families as they utilize the department’s services.

“We wanted to have a centralized reception area so that our customers know where they can come in. We also wanted to secure the building better because there is a lot of confidential material that staff [members] work with,” said Hudson. “We have a larger training room with state-of-the-art

Human Resources WIOA Program Offers Employment and Education Assistance

For the past 15 years, the Human Resources WIOA Program has helped hundreds of youth and young adults gain work experience and training for future employment. The Workforce Innovation and Opportunity Act offers in-school, after-school, summer youth programs and a program for those 18-years and older. When the program first began it was known as the Workforce Investment Act (WIA).

Many of you may be familiar with the summer youth employment program, but what you may not know is that there is an adult component to the program as well.

The mission of the program is to assist adults in becoming self-sufficient by providing education and training services leading to gaining employment. This will improve the quality of life, strengthening the workforce and enhance the productivity of the SRPMIC.

The program is a committed partnership between the case manager and participant, meaning there is a plan and goal that must be met in order to partici-

pate in this program.

The adult program is open to anyone 18 years and older who have a GED or High school diploma. "Students who are a part of the WIOA Program who choose to work and attend school the decision is up to them based on their needs," said Amy Francisco, WIOA Program supervisor. "It is recommended they balance it out so they can be successful in school and work."

Some of the popular questions adults have about the program are:

Can I be part of WIOA and be working with higher education? The answer is yes, many of the participants are also receiving assistance from higher education.

Does WIOA assist with finding jobs? WIOA is education and training based. Once a participant completes their training, the program can assist with job search and once employment is obtained assist with work clothing.

Is there an eligibility requirement for the program? Yes, there are eligibility requirements which are discussed at the orientation. See sidebar for additional information.

If participants are interested in


school, the program asks that you fill out a FAFSA at (www.fafsa.ed.gov). The program encourages participants to pursue grants and scholarships.

The WIOA Program supports adults with tuition, text books, supplies and work clothing.

For the program to support you they ask that you keep your contact information up -to-date, and communication with case managers. If participants do

not maintain contact with the program, they will not be eligible to re-enroll for two-years after the exit date.

Workshops are also hosted to participants to enhance skills. If you are interested in the program for the spring and fall semester and deadlines contact the WIOA program at (480) 362-7962.

- Be unemployed or underemployed (part-time)
- Have a high school diploma or GED

- Social Security Card
- Tribal membership
- Income verification (last six months)
- Household verification
- GED (transcripts), high school diploma, certificates, degrees, etc.
- All documents must be turned in with a completed application to be considered for eligibility.

Salt River Pima-Maricopa Indian Community member Ezekiel "Zeke" Mendoza, along with his high school friend Roman Romero, opened Prime Kicks and Cuts in downtown Mesa in 2015 to provide streetwear, sneakers and a barber all in one location.

In the robbery the pair lost more than \$40,000 in merchandize and damages.

"Fortunately, we were covered by insurance, it was just a hassle having to picking up after everything. It was a rude awakening," said Mendoza.

The unfortunate incident led the owners to find a new location in hopes of gaining more customers and possibly more profits.

"I think the opportunity lined itself up. We were in downtown Mesa for about four years, and

that location has been great to us," said Romero. "We always had a vision to be in a very high-traffic area, and there was no better opportunity than coming to the mall."

Prime Kicks and Cuts provides brand-name clothing, but they also carry local and in-house clothing lines as well. They carry limited and rare shoes such as Jordan, Nike and Yeezys; they carry clothing from brand names such as Supreme and Bape.

When asked if they had any advice for those looking to start a business, the pair agreed that "Just do it" was a good motto. They said you have to keep working and working, and don't ever give up.

The season started in early September, but practice started in August and the heat forced the team to practice inside at times. Nevertheless, Roanhorse said runners were more than willing to

go outside and get their miles along the canal. The team has returning runners as well as welcomes new runners.

Roanhorse said the season strategy was to build workouts over time and to start making their move in October.

"A highlight from this season is that all returning cross country runners had an all-time low for their season opener," Roanhorse said. "Many cut off at least a minute from their time."

"As of right now, our athletes are all working on individual goals for the season, which has been a weekly effort every practice as to drop their times in race. Many set a goal of dropping a minimum of two minutes from their race time."

The Canyon Athletic Association hosts the state championships on November 2 in Goodyear, Arizona.

Top-seeded Stapley Junior High School, led by Salt River Pima-Maricopa Indian Community members Sam Hill and Joseph Schurz, nearly overcame a slow start and a 13-point halftime deficit in the Mesa Public Schools championship game on September 27.

Stapley easily beat Smith and Poston to start the tournament before running into a disciplined and tough Taylor team in the eighth-grade boys' basketball championship game. Stapley hosted the game and beat Taylor at their gym a week before, capping an undefeated regular season, only to see Taylor get its revenge 40-29 in a packed Stapley Junior High School gym.

"We couldn't get stops, we weren't playing defense, and we missed lay-ups and free throws," Schurz said after the game.

Hill and Schurz started for Stapley, and both played most of the game. Hill plays mostly point guard and Schurz is a wing player. On defense, they can be a nasty combo during the team's staple full-court press, as each is quick enough to disrupt passing lanes and stay in front of their opponent.

Games consisted of four 6-minute quarters. Stapley struggled to score in the first half and finished with 11 at halftime to Taylor's 24. A day before, Stapley was up 30-9 in the semifinals at the half after a stellar defensive effort. Stapley's full-court defense didn't work as well against Taylor. Plus, with Stapley not shooting well, the game quickly turned to Taylor's favor.

"We stunk on defense," Hill said. "They were ready and we weren't at the start."

The second half of the championship game was different, as Stapley got back within single digits and recaptured some of the momentum. They were down by 8 points at the end of three and got within 5 points mid-fourth quarter; they even had a couple of chances to get closer but missed key shots. Taylor sealed the game with late baskets.

Hill said winning the MPS championship was a goal of his and he knew if they met Taylor again in the tournament that it would be a tough game.

The championship game was the end of the sanctioned junior high team's season. Both Hill and Schurz said they'll play club ball coming up, with basically the same roster.

Both have been playing organized basketball since third grade and love the game.

"[I love] everything about the game. It's fun and it's fun playing with other people," Hill said.



On September 17th, the JCDC submitted their annual report to the Council Secretary for calendar years 2017 and 2018. Council is publishing this report in the newspaper as required by the Code of Ordinances.

JUDICIAL CONDUCT AND DISCIPLINE COMMISSION ANNUAL REPORTS FOR CALENDAR YEARS 2017 AND 2018

In accordance with Section 4-25(h), SRPMIC Court Rules of Professional Conduct, the Judicial Conduct and Discipline Commission files and presents to the Council the annual reports for calendar years 2017 and 2018. This report includes the following information: 1) The number of complaints that were received by the Commission during each year, 2) the number of complaints filed against each judge, 3) the final outcome of the Commission's review regarding all complaints filed including complaints that were determined to not have merit, and other related information the Commission deemed appropriate.

Two Complaints in 2017

Case 1: A complaint was filed against Judge Anthony Little and the SRPMIC Court as a whole by XXXXXXXX on October 18, 2017. The complaint describes her experience in attempting to obtain a restraining order against a named person. Her request for the order was to be heard before Judge Little. When she arrived late for court, the bailiff informed her petition was dismissed when the matter was called before she arrived. The complaint against Judge Little was dismissed by the JCDC on November 2, 2017 upon a determination by the JCDC that there was insufficient information evidencing "misconduct" by Judge Little to warrant further investigation. Although the complaint also appeared to include allegations of misconduct by "the court system as a whole," the JCDC is restricted under Ordinance Number SRO-435-2014 to allegations of misconduct regarding judges who serve on the Community Court.

Case 2: A complaint was filed against Judge Paula LeBeau by XXXXXXXX on June 23, 2017. The complaint arose out of continuing litigation over child custody and visitation issues that were before Judge LeBeau. After review and investigation, which included listening to recorded portions of the proceedings, the JCDC found insufficient information evidencing misconduct to warrant further investigation. The complaint was dismissed by the JCDC on August 2, 2017.

One Complaint in 2018

A complaint was made against Chief Judge Ryan Andrews by XXXXXXXX on October 16, 2018. XXXXXXXX worked directly for Chief Judge Andrews as XXXXXXXX to the SRPMIC. XXXXXXXX letter of complaint about Chief Judge Andrews was first sent to Human Resources. It was then referred by HR to the JCDC for a determination of whether Chief Judge Andrews violated XXXXXXXX personal privacy by observing her on a court security monitor while privately eating her lunch, and then making statements to her about his observing her without her knowledge and consent. On November 9, 2018, the JCDC requested the appointment of Arizona licensed attorney, Sonya Boun, to conduct an investigation into the matters raised in the complaint. In the course of the investigation Chief Judge Andrews was provided all information available about the complaints made against him. In further course of the investigation, Chief Judge Andrews agreed to accept a Formal Reprimand and admit to the allegations set forth in Count I of the charges against him. 

SRMG Clarkdale Plant Receives 3rd PCA Innovation Award

Salt River Materials Group's Clarkdale Cement Facility was recently honored with a third PCA (Portland Cement Association) Safety Innovation award.

An independent panel of judges selected Salt River Materials Group's Clarkdale Cement Facility as the 2019 Overall Winner in the Milling & Grinding category for our "Table Liner Lifting Clamp" design. This marks the 3rd time Clarkdale has been honored with a PCA Safety Innovation Award having also won in 2011 for our Truck Tarping System and in 2016 for our Roller Assembly Stand.

The Back Story

Sometime in late 2017 or early 2018 FL Smidth changed the design of the liners that make up the grinding surface for the table on Clarkdale's vertical cement mill also known as the O.K. Mill or RM-305. This is the cement mill at Clarkdale that produces the bulk of the Type II/Type V cement for SRMG.

The original table liners were designed with places for lifting lugs designed into the castings. Their job was to help facilitate handling the liners when installing or removing them by providing a place to attach rigging to lift and handle them. These were very important because each oddly shaped liner weighs approximately 2,162lb and the grinding surface on the mill table is comprised of 12 of them. That means 24 of them (12 out/ 12 in) or about 52,000 pounds worth of liners have to be moved to rebuild the table.

However, FL Smidth determined that the lifting lug fittings in the original design were a weak point and contributing to cracks and premature failure of the liners. Their solution: remove them from the castings. This change meant that we would have to figure out how to safely

Recognizing that a vital tool (and a Safety tool at that) was going to be absent for the next liner change, Kyle Shanahan the Supervisor of our 54 Maintenance crew here at Clarkdale raised the alarm and we started trying to figure how we were going to safely hook up to and handle the liners during the upcoming liner change. With scheduled table rebuild just a few months away, we didn't have much time to come up with a solution.

The real challenge was that there was nothing "off the shelf" that could meet this specific need and FL Smidth did not provide an alternative solution when they changed the liner design. It was up to us to "save" ourselves.

After getting input from several employees who have worked with the liners as well as several brain storming sessions with Maintenance Manager Darrell Sterrett and VP of Cement Operations Gregg St.Clair, it was decided that a lifting device fitted for the liners would be our best and safest option.

With our scheduled table rebuild for the O.K. mill getting closer by the day, there was no time to waste. Kyle set to work and enlisted one of our long term and trusted fabricators (Arizona Equipment Fabrication) to start making the clamp a reality. AEF began turning ideas and scribbled drawings into an engineered and certified cold steel lifting tool.

The end result was a lifting clamp constructed of plate steel capable of grabbing and trapping the 2,162lb liners to hold them securely within its angled ends.


shifting while being transported in and out of the mill.

The Table Liner Clamp was put to work just a few short weeks after it was built. It worked almost flawlessly from the start. Though it came about because of a design change to the liners, the unintended consequence of building the Table Liner Lifting Clamp was that it also improved safety (more durable and secure than slings) and sped up the job of moving the liners considerably. It's a tool that will now be used for as long as we have vertical mills and table liners.

Unintended Consequences

One of the neatest unintended consequences of solving a challenge like this is that through the PCA and also our direct contacts, we were able to share our solution with others who have similar equipment and faced the same challenge.
