The Salt River Pima-Maricopa Indian Community Administration and Young River People's Council presented a financial literacy workshop at the Way of Life Facility on Friday, November 15. The goal of the class was to introduce Community youth ages 12 and older to the basics of money management.

The event started off with SRPMIC President Martin Harvier welcoming up to 100 youth, parents and volunteers to the event.

"I am hoping this is a kickoff to something larger in the future as far as financial literacy for the [younger] members of our Community. It's good to see the parents and the children who are here," said Harvier in his welcome message.

Northern Arizona University's Gwendolyn Cody and her staff presented the Seven Generation Money Management game to the youth and their parents. The game is a hands-on financial literacy game targeted to youth to enhance their money-management skills. It provides an understanding of bank accounts, investing, buying a house, purchasing a car and other money-related life skills.

Everyone divided into two groups. The

# Fourth Annual Journey to Wellness Community Education Day

On November 14, Salt River Pima-Maricopa Indian Community's Diabetes Prevention Services hosted the fourth annual Journey to Wellness Community Education Day at the Salt River Community Building. Because November is Diabetes Awareness Month, the event always takes place around this time of year. The theme for 2019 was "Mindful Living."

"This is the fourth year we've offered the Journey to Wellness event for Diabetes Awareness Month," said Elissa Caston, Diabetes Program supervisor. "We like showcasing our [own] program and staff, [but] these events [give us] an opportunity to bring in guest speakers to present on special topic areas."

The morning started with participant check-in, a light breakfast of bagels and coffee, and a recipe box decorating activity.

The first guest presenter was chef Maria Parra Cano of Sana Sana Foods, a plant-based food company with the goal of healing communities that suffer

from hypertension and diabetes. The company educates community groups about ancestral/traditional foods by hosting cooking classes, workshops and demonstrations, and providing catering. Sana Sana only uses products grown in the Valley.

Speaking on the topic of incorporating ancestral foods into the diet, Cano discussed family remedies and how indigenous foods can be used as medicine to help manage diabetes and hypertension. She shared her personal struggle with diabetes and how it affected her family. "I hope we are able to heal everyone from this disease," she said. She credited her belief in eating foods that the ancestors ate and using remedies they once used in helping her become healthy again.

Cano provided a morning snack and demonstrated how to make quinoa con leche. Participants also put together their own "ancient granola" mix, consisting of popped amaranth, sunflower seeds, quinoa, chia seeds, berries, almonds and walnuts. The mix is a healthy way to start the day with protein and carbohydrates. The "make and take" project at the end of day included black beans, pinto



beans, purple hominy corn and seasonings. Participants took home the recipes for the meals they got to enjoy.

Next, Dion Begay of the SRPMIC Diabetes Prevention Program led participants in several mobility drills. The purpose of the drills was to teach some simple stretches using household items like a broom, mop or length of plastic PVC pipe.

"I hope everyone finds this very educational and starts doing this daily," said Begay. The different movements take a minute at most to do. He emphasized the importance of maintaining flexibility in the joints, because "when we don't stretch, our muscles become shortened and tight."

Wellness educator Stephanie Kreun with Simply Healthy Nutrition discussed nutrition and mindful eating. "It's all about being cautious and being aware of what and when you are eating," said Kreun. She explained the difference between mindful and mindless eating and talked about the benefits of eating and chewing your food slowly. She recommended chewing each bite at least 15 times before swallowing.

As an example of mindful eating, Kreun passed out raisins and cranberries. She asked the participants to take a minute to feel the item with their fingers, then put it in their mouth and think about the texture, smell, taste and sound.

"This is something you can do at home with your meals. Let a dialog start happening for one meal to bring the family together," said Kreun.

The rest of the day was filled with more exercise tips and raffle prize drawings.

Caston noted that this was the fourth year that the event offered a plant-based lunch. "I wanted participants to experience a meal that didn't include meat [but] is still filling and delicious. In our area of work, we always hear about people not eating enough vegetables. These meals offer some new ideas for how to prepare and cook vegetables."

The Diabetes Program recently presented an assembly at Salt River Schools and brought in three guest speakers to talk with the students about their journey to wellness and share what they are passionate about.

"We also offered a Family Night event at Salt River High School. Our guest speakers talked about how to have the tough conversations with your teens on substance abuse, mental health and suicide prevention," said Caston.

"I love that we get the opportunity to teach folks about their health and wellness. Everyone is on their own journey to wellness. It's important for people to feel supported on this journey. It's not easy, but if we learn from each other and support each other, we can reach our goals," said Caston. She extended a big thank-you and shout out to Fitness-Fest for helping with all the events.

Diabetes Prevention Services offers health education classes, cooking sessions, group exercise classes and more. first group went to the basketball courts at the Way of Life Facility, which had been converted into businesses such as a car dealership, an insurance office, a college admissions office, a bank, an electronics store, a travel agency, a furniture store, a tax office and many others. To play Seven Generation Money Management, participants were given ledgers to track their income, saving and spending. Everyone kept track of how much they spent and how much money they earned through their jobs, per-capita payments and investments. The youth had to visit at least 10 booths and

write down what they bought, and list their investments, debts and income. They learned how much a new smartphone really costs with all the fees included. They also learned about the difference between making payments or paying for an item in full.

SRPMIC employees volunteered at each booth, explaining how much it costs to pay for a family vacation, to buy a home or rent an apartment, to buy a car and pay for the insurance, and how much they might owe the Internal Revenue Service each year. The youth were able to experience what it is like to be respon-

sible adults, but in a fun way.

While the first group was playing the game, the second group went to the WOLF kitchen, where they enjoyed a pizza dinner and listened to a presentation from the Providence First Trust Company. Then both groups switched stations and the second group played the money management game.

Raffle prizes included gift cards and electronic items. The grand prize was an Apple laptop.

## Pueblo of Isleta Citizen Delivers Opening Prayer in Congress

On November 13, Verna Teller (Isleta Pueblo) became the first Native American to deliver the opening prayer in the U.S. House of Representatives. Teller was dressed in traditional Pueblo clothing and was introduced by Speaker of the House Nancy Pelosi.

Teller, a former tribal lawmaker, is the chief judge of the Pueblo of Isleta. Rep. Deb Haaland (Laguna Pueblo) posted multiple photos of her and Teller behind the scenes, including a viral video clip of the pair walking down a hallway to the House Floor in the U.S. Capitol.

## Arizona Recognizes Native American Heritage Month

Arizona Governor Doug Ducey issued a proclamation declaring November 2019 Native American Heritage Month in Arizona.

Ducey issued the proclamation on November 13.

"Arizona is proud of the diversity and cultural richness advanced by the 22 tribal nations and communities throughout our state," he said. "Native American culture and identity are an intrinsic part of Arizona's past, present and future. In recognition of the unique ways that Native American communities enhance the vitality of our state, it's my honor to proclaim November Native American Heritage Month."

## Cherokee Nation Opens Largest Health Center Operated By a Tribe

The Cherokee Nation opened a four-story, 469,000-square-foot outpatient health center on November 14.

The new facility is located in Tahlequah, Oklahoma. It has more than 240 exam rooms, an ambulatory surgery center, two MRI machines, primary-care services, 34 dental chairs, full-service optometry and special health services, according to a news release.

The tribe will operate the facility, and the Indian Health Service is providing \$100 million annually for staffing and operational costs. The Cherokee Nation invested \$200 million into the facility's construction and equipment, according to the news release.

On November 2, musician Shelley Morningsong (Northern Cheyenne) took home the top prize at the 19th Annual Native American Music Awards (NAMMYs), which were held at the Seneca Niagara Resort and Casino in Niagara Falls, New York.



# Cultural Preservation Program Staff Represent SRPMIC at NAGPRA Conference

Cultural Preservation Program Manager Shane Anton and Compliance Supervisor Angela Garcia-Lewis represented the Salt River Pima-Maricopa Indian Community in panel discussions at the Association on American Indian Affairs' Fifth Annual Repatriation Conference, "Healing the Divide," held November 12-14 at the Fort McDowell Yavapai Nation's We-Ko-Pa Resort and Conference Center. The annual conference invites all those involved in efforts to repatriate cultural artifacts for tribal nations to join in an atmosphere of healing, sharing and learning.

NAGPRA is the Native American Graves Protection and Repatriation Act of 1990. It states that Native American remains, cultural items and sacred objects that reside in museums, private collections or repositories, or are excavated or discovered on federal or tribal land, belong to the tribe in question and must be returned to the lineal descendants from that tribe. According to their website, the goal of AAIA's annual repatriation conference is to "unite tribes, federal agencies, foreign and domestic museums, dealers, collectors, auction houses, academics, and others to better our processes and the way in which we work with one another and establish a healthy future for all of us involved in repatriation."

Garcia-Lewis sat on the Building NAGPRA Community of Practice panel. Joining her were Anne Amati, NAGPRA Coordinator, University of Denver Museum of Anthropology; Lydia Dean-Sutton, M.A. candidate, University of Denver; and Ellen Lofaro, NAGPRA Coordinator and Curator of Archaeology, Anthropology Department, University of Tennessee. They discussed the issues affecting NAGPRA implementation in museums and the initiative to create a NAGPRA community of practice.

Garcia-Lewis discussed some of the

issues affecting SRPMIC efforts in the repatriation process, which include lack of communication from both sides.

"This is something that impacts people in a very real and personal way. This job dealing with NAGPRA and cultural resources isn't something that you

can forget about at the end of the day. There are individuals still being held in museums and repositories, and every day we worry about them, we wonder how soon we can get them back," said Garcia-Lewis. "It is a real relationship and obligation that tribal people have, and it's not understood by institutions that are used to following a process [in dealing with cultural artifacts]. That can hinder real communication."

Garcia-Lewis explained that while institutions have to comply with NAGPRA, some are not fully invested in it. She also shared advice on how organizations can educate others about repatriation through presentations and consultations.

The next day, Anton sat on the panel called Inter-Tribal Efforts: Tribal Nations Developing Unity of Strength and Position. The other panel members were Shannon Martin, NAGPRA Designee, Director of the Ziibiwing Center of Anishinaabe Culture & Lifeways; Colleen Medicine, Director of Language & Culture, Sault Ste. Marie Tribe of Chippewa Indians; Reylynne Williams, Cultural Resource Specialist, Tribal Historic Preservation Office, Gila River Indian Community; and Timothy McKeown, Senior Adjunct Research Fellow, National Centre for Indigenous Studies,

Australian National University.

The topic of this panel was how tribes can collaborate and support each other's efforts to repatriate their cultural artifacts. Anton discussed the collaboration and support between the SRPMIC Cultural Preservation Program and its sister tribes GRIC, the Ak-Chin Indian Community and the Tohono O'odham Nation when it comes to all matters regarding repatriation efforts and cultural protocols. These communities get together monthly to make sure they are all on the same page and doing things correctly when it comes to these cultural matters and that they are supporting each other in the southern Arizona region.

"As Native people, we decide amongst ourselves, we don't fight for remains, and we all agree that ... there is a certain way [tribal remains and artifacts] should be brought home and certain cultural protocols on how your heart and mind are," said Anton as he explained how the four tribes decide how to handle found remains in the O'odham and Piipaash territories in southern Arizona. "Fighting over them is not culturally correct, so we sit down and come to an agreement of which community they should go to and that it should be done respectfully."

Anton also said that the four tribes and other surrounding Indian tribes help when they are having a difficult time collecting remains found in the O'odham and Piipaash territories.

SRPMIC Vice-President Ricardo Leonard and Council Representative Archie Kashoya participated in the conference along with the Cultural Resources staff. During the Association on American Indian Affairs' 97th Annual Membership Meeting and Cultural Event, held along with the annual conference, the Salt River Pima-Maricopa Traditional Dancers performed a number of traditional songs and dances.

The Sixth Annual AAIA Repatriation Conference will be held October 27-28, 2020, in Denver, Colorado.

Youth participated in numerous activities like arts and crafts, competitive games with a cultural twist, and even learning how to shoot a bow and arrow.



"I hope to see more people join us for future walks and to spread more awareness about this issue of MMIW."



## Native Art Market at Talking Stick Pavilions

If you're in need of a last-minute holiday gift and want to support Native business owners and small business, the Native Art Market is a must.

On Saturdays and Sundays through the end of March, Native American artisan vendors will take over a parking lot at the Pavilions at Talking Stick in the Salt River Pima-Maricopa Indian Community's business corridor on the west side.

The vendors are part of the Native Art Market and are coordinated by mother-daughter team Denise Rosales and Heather Tracy, both of the Navajo Nation.

The market is open from 9 a.m. to 5 p.m. on Saturdays and 9 a.m. to 4 p.m. on Sundays. It's free and open to the public. The market is across Loop 101 from Talking Stick Resort in the parking lot next to Popeyes chicken. If you see the rows of vendor tents, you're in the right spot.

"This is all for our community, the community members, Salt River, artisans and small business owners," Rosales said.

The market opened this year in October, a month earlier than planned due to high demand, Rosales said.

Each weekend, about 30 Native American artisans from across the Valley, Arizona and some from New Mexico set up booths showcasing a variety of handmade jewelry and art for sale. A food vendor on site can satisfy your urge for a piece of frybread. The market also provides entertainment in the form of music and traditional and

contemporary dancers.

The market is accepting vendor applications. To apply, a certificate of Indian blood is required. The application fee is waived for SRPMIC Community members.

More than 300 vendors and Native performers have registered, so vendors and performers vary on each day. Artists from SRPMIC have participated.

"Native Art Market creates a unique opportunity for Native Americans to enhance and develop their economic self-sufficiency in the metropolitan area," according to its website. "Above all, families involved with the project have gained economic empowerment and pride in themselves. (The market) strives to provide a safe and affordable avenue for Native Americans to sell their handcrafted items directly to the public."

## Community Recreational Services Presents Archery to Youth

Salt River Pima-Maricopa Indian Community's Recreational Services presented an archery class for interested Community youth at the Way Of Life Facility (WOLF) on November 18. The class is part of the special-interest classes that the department hosts throughout the year.

A handful of youth attended. Class instructors Kevin Riding-In and Ephraim Sloan both reviewed safety measures and demonstrated the different bows and the arrows that the students would be using that evening.

"This is the first time we have offered archery as a special-interest class open to all Community members," said Riding-In. "In the past, it was a class open to after-school or day-camp participants."

The youth were taught how to handle the bows and arrows cautiously with one-on-one training from the staff.

Both Sloan and Riding-In said the class turned out great.

They reviewed basics like safety, handling the bow and arrow, how to hold both, where to position the three fingers, becoming comfortable holding the arrow and letting go, and aiming at the target. Students also learned how to retrieve the arrows from the targets properly, without breaking them.

"The kids listened well, followed the set rules and really had fun shooting arrows. The staff also was very helpful, and parents stayed to watch their kids participate, which was awesome as well," said Riding-In. "Parents liked watching their kids learn and perform new skills. I think they would like to see more archery classes offered."

# History of the Pearl Harbor Memorial Flag

In October 2007, members of American Legion Post #114 and then Salt River Pima-Maricopa Indian Community Vice-President Martin Harvier flew across the Pacific Ocean to Honolulu, Hawaii, to retrieve one of the flags that once flew over the USS Arizona Memorial at Pearl Harbor National Memorial. As veterans, veterans' organizations and the nation prepare to remember those who were lost and injured during the Japanese attack on Pearl Harbor on December 7, 1941, it's important to remember how the Community obtained a flag that once flew over the USS Arizona Memorial.

The late Joel Jefferson, a member of American Legion Post #114 Bushmasters, led the push to obtain the flag for the Community. More than 12 years ago, he established communication with Skip Wheeler of the National Park Service, who took Jefferson through a lengthy process. After much back-and-forth communication between the two, American Legion Post #114 and the Salt River Pima-Maricopa Indian Community were granted a flag on October 12, 2007.

"We had a lot of heroes, highly decorated veterans that were in World War II, and Jefferson wanted to have them remembered. Having a USS Arizona Memorial flag helps us remember all of those veterans," said Thomas Jackson, American Legion Post #114 member and Huhugam Ki Museum assistant. "Another reason it was important to us and the Community is because SRP-MIC member Raymond Valenzuela (U.S. Navy, World War II) was at Pearl Harbor when the attack happened. He helped a lot of the sailors out of the water. He was on his way to his duty

station when the attack hit; he was right in the middle of all of it. He and a few others started to pull out the injured men."

This was the first and only USS Arizona Memorial flag granted to an all-Native American Legion Post and tribal community. Post #114 and the Community have been sharing the flag with more than 25 other American Legion

posts and veterans' groups since 2008.

"The very first year we had the flag, we ... [realized] that this is very serious, and we're going to have to share this every year," said Jackson. "When we started sharing [the flag], the Arizona State Capitol Museum found out and they asked if it could lie in state there. We don't refuse anyone [who wants] to take a look at it or do a ceremony with

it, as long as it's appropriate."

The flag just traveled to Gila River and will be brought back to Salt River for the Pearl Harbor Remembrance Day event on Friday, December 6, at the USS Arizona Memorial Gardens at Salt River Fields. On the following day, American Legion Post #39 in Gilbert will take the flag and conduct their own ceremony.

## USS Arizona Memorial Relic Update

## Archiving Workshop Helps Families Preserve History

The Salt River Pima-Maricopa Indian Community Tribal Library partnered with the Arizona State University Library for a Family Archiving Workshop at the Way of Life Facility on Tuesday, November 12. The purpose was to teach Community members how to properly restore and archive their family photos, keepsakes and mementos.

This workshop is part of the ASU Library's efforts to preserve Arizona history. Alex Soto (Tohono O'odham) of the ASU Library, along with his colleagues, presented the four steps for preserving and archiving historical photographs and mementos. The ASU Library is encouraging families to preserve their history because there is a lack of representation of Latino, African American, Asian American and LGBT communities and cultures in the State of Arizona's archives.

The ASU Library provided an archiving starter kit to the participants, which contained preservation information and archival supplies including an acid-free box, folders, mylar sleeves and cotton gloves.

The first step in the archiving process is to appraise and evaluate the materials (photographs, cards, posters, diaries, scrapbooks and other materials). The second step is to arrange and describe the material, organize the material by type or subject, identify people and places, and create a finding aid that tells you what's in each box or folder. The third step is to preserve the items by storing them in a clean, dry

place, such as in acid-free folders and boxes and mylar sleeves. When handling delicate items, it's best to use cotton gloves. The final step is digital preservation by converting photographs and old films to digital format by scanning the originals and saving to an external hard drive.

The workshop participants did hands-on work, handling old photographs and newspapers. They looked at the photographs and tried to figure out the time periods and what type of photograph it was (portrait, action shot, etc.). These exercises were helpful to show people the different ways to gather information about a photograph to have it properly archived.

"Our goal is to educate people about archiving during these workshops through the Salt River Tribal Library. Hopefully the participants can continue on and teach their families and possibly their community in the future," said Soto.

All youth were able to attend, but young girls interested in golf were the event's target. Golf clubs were provided. Participants learned how to properly hold and swing a golf club with the guidance of Begay and Lemieux. Both are Nike N7 influencers.

#### Notice of Proposed Water Rate Options – Input Needed

The SRPMIC Public Works Department is currently presenting residential water rate options for consideration by the Community Council and Council would like your feedback on the options being presented. A survey will be sent out in December's residential water bill. Please return the survey in the prepaid return envelope (that will be provided) by December 31, 2019.

The current Council approved water rate that has been in place since 2006 is made up of a base fee plus a usage fee. The base fee is \$4.00 which allows up to a usage of 6,000 gallons. The usage fee applies for usage over 6,000 gallons and is at a rate of \$0.38 per 1,000 gallons.

#### Why are proposed residential water rate options being considered now?

Due to a meter reading error discovered in 2018, all residential customers' water bills were temporarily adjusted to only charge the \$4.00 base fee and not the usage fee. Accounts had to get fixed and in order to prevent customers from getting unanticipated higher water bills, the adjustment was made until all accounts were corrected. Now that all accounts have been corrected, Public Works sought guidance from the Community Council on how to proceed going forward and several options were presented.

#### So what are the proposed options for residential water rates?

There are five options for consideration:

- **Option 1: Keep the temporary rate in place** (\$4.00 base fee only)
- **Option 2: Revert back to the current Council approved water rate** (\$4.00 base fee plus water usage fee of \$0.38 per 1,000 gallons after first 6,000 gallons)
- **Option 3: Provide free water**
- **Option 4: Create a tiered water rate** (similar to City of Scottsdale, City of Mesa, etc)
- **Option 5: Create a flat fee for all services provided by Public Works** (includes water, trash and septic/sewer services)

## NOTICE OF COUNCIL DELIBERATION ON REQUEST FOR PERMANENT EXCLUSION OF

On October 29, 2019, the Salt River Pima-Maricopa Indian Community's Exclusion Committee held a hearing to consider whether Respondents Jesus Manuel Flores, Francisco Luna Mendoza, and Abraham M. Arellano-Valadez should be permanently excluded from the SRPMIC. Respondents Flores and Valadez attended the hearing, while Respondent Mendoza did not. After hearing the evidence, the Exclusion Committee is recommending that the Council exclude Jesus Manuel Flores, Francisco Luna Mendoza, and Abraham M. Arellano-Valadez from the Community as the Committee determined that they are not enrolled members of the Community and that their presence within the SRPMIC is detrimental to the peace, health and morals of the SRPMIC. This recommendation is based on the significant number of police contacts that the Salt River Police Department has had over a three (3) year period regarding reports of burning trash, illegal dumping of trash and dead roosters, promoting and holding illegal cockfighting matches, complaints of noise, smells and smoke, public intoxication and disorderly conduct, and animal cruelty. These police contacts occurred at 3001 N. Harris Drive and were conducted by Respondents Jesus Manuel Flores, Francisco Luna Mendoza, and Abraham M. Arellano-Valadez.

On Wednesday, December 18, 2019, the Community Council will determine if they accept the Exclusion Committee's recommendation. The Council meeting will begin at **5:00 pm on Wednesday, December 18, 2019 at the Community's Administrative Complex, Two Waters, Council Chambers (the Administrative Complex is on the corner of Longmore and Osborn Roads) Scottsdale, Arizona 85256.**

Respondents Jesus Manuel Flores, Francisco Luna Mendoza, and Abraham M. Arellano-Valadez have until Monday, December 16, 2019 to provide any written material or a written petition supporting or objecting to the Exclusion Committee's recommendation to permanently exclude them from the boundaries of the Community as their presence within the SRPMIC has been determined to be detrimental to the peace, health and morals of the SRPMIC.



**AN ORDINANCE TO AMEND CHAPTER 4, SECTION 33(f) OF THE SALT RIVER PIMA-MARICOPA INDIAN COMMUNITY CODE OF ORDINANCES TO AMEND THE VACANCY REQUIREMENTS OF THE CHIEF JUDGE POSITION TO ALLOW THE COUNCIL AND THE COMMUNITY TIME TO DISCUSS POTENTIAL UPDATES TO THE ORGANIZATION OF THE COMMUNITY COURT.**

**BE IT ENACTED:**  
Chapter 4, Section 33(f)(1) is amended by immediately repealing the entire provision and replacing with the following:

(f) *Vacancy.*  
(1) *More than two years left in term.* If a vacancy occurs in the office of chief judge of the Community court and there are more than two years remaining in the term of the office, the Community Council shall call an election to be held at a time to be determined by the Community Council, but in no event more than 180 days after the date the vacancy occurs. Subsections (a), (b), (c) and (d) of this section shall be applicable to the filling of the office of chief judge by election, pursuant to this section except as is provided for in this section and except that the submission required under subsection (b) of this section shall be made no less than 15 days before the day set for the special election.

**CERTIFICATION**

This Ordinance is hereby enacted pursuant to the authority contained in Article VII, Section 1 of the Constitution of the Salt River Pima-Maricopa Indian Community ratified by the Tribe, February 28, 1990, and approved by the Secretary of the Interior, March 19, 1990, and amended by the Tribe, February 27, 1996, and approved by the Secretary April 23, 1996, the foregoing Ordinance was adopted this 30<sup>th</sup> day of October, 2019, in a duly called meeting held by the Community Council in Salt River, Arizona at which a quorum of 9 members were present by a vote of 9 for; 0 opposed, 0 abstentions, and 0 excused.

**Second Update to the Community on the Community Court**

\*Presented to the Community at the Regular Session Council Meeting on Wednesday, October 30, 2019

**Resignation of Ryan Andrews.** Today, Ryan Andrews resigned as Chief Judge of the Community.

The Council informed the Community that on September 5, 2019, a complaint alleging judicial misconduct was filed with the Community's Judicial Conduct and Discipline Commission against Chief Judge Ryan Andrews.

**Complaint Allegations.** The complaint alleged six (6) main allegations of judicial misconduct against Chief Judge Ryan Andrews, and also called for his removal from the Office of the Chief Judge. The allegations of judicial misconduct involve allegations of inappropriate behavior and misconduct as a judicial official, lack of management and supervision as Chief Judge, failure to implement Community law, as well as other allegations of judicial misconduct.

Prior to his resignation, Chief Judge Ryan Andrews was provided the entire 24 page Complaint along with all its exhibits.

**Next Steps.** Council also informed the Community that it had a comprehensive Court Assessment completed regarding the administration of the Court. The Council hired two experts in the field of Indian law and tribal courts. The experts' findings informed the Council that more resources, training, and expertise are needed at the Court, to improve the delivery of services to the Community and its members.

With the resignation of the Community's Chief Judge and with the recommendations of the recent Court Assessment, the Council has tasked itself, the Community Manager, Community Court staff and Judges, and other key stakeholders to make immediate improvements to the Community Court.

In the next six months, Council will work with the Community to update the structure of the Community Court. Its current structure has not been updated since 1980. Its 40 years later, and its time to re-assess what is the best way to meet the needs of the Community.

**Thank you to the Court Staff.** Council would also like to thank Acting Chief Judge Achin who is serving the Community well, in this acting capacity, and we thank her for her leadership at this important time. The Council also thanks the court judges and staff for their hard work during this difficult time.


